

NOTICE OF MAKING OF AN ORDER
HIGHWAYS ACT 1980
THE VALE OF GLAMORGAN COUNCIL
(PUBLIC FOOTPATH NO 43 BARRY)
PUBLIC PATH DIVERSION ORDER 2019

The above Order, made on the 18th July 2019, under Section 119 of the Highways Act 1980, will divert the public footpath located within Porthkerry Park running from NGR 308658 166782 south-westwards to NGR 308472 166421 to a line running from NGR 308711 166721 eastwards parallel to the coastline to NGR 308472 166421 as shown on the Order map.

A copy of the Order and the Order map have been placed and may be seen free of charge at the Docks Office, Subway Road, Barry, Vale of Glamorgan, CF63 4RT during normal office hours. Copies of the order and map may be bought there at the price of £4.50.

Any representations about or objections to the Order may be sent in writing to the Head of Regeneration and Planning, Docks Office, Subway Road, Barry, Vale of Glamorgan, CF63 4RT not later than the 5th September 2019. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the Order as an unopposed order. If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
