

**NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER
HIGHWAYS ACT 1980**

THE VALE OF GLAMORGAN COUNCIL

(PUBLIC FOOTPATH N^o. 43 PENDOYLAN)

On the 16th July, 2019 the Vale of Glamorgan Council confirmed the above Order made under section 26 of the Highways Act 1980.

The effect of the Order as confirmed is to create a public footpath from Bolgoed Farm, Hensol (NGR 304078 179633) along a track to Fforest Fach Farm, Hensol (NGR 303902 179699) as set out in the Schedule and shown in the Order map.

A copy of the Order as confirmed and the Order map may be seen free of charge at the Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT during normal office hours. Copies of the Order and map may be bought there at a price of £4.50.

This Order comes into force on 16th July, 2019, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 8th August 2019 make an application to the High Court.
