

**NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER  
HIGHWAYS ACT 1980**

PUBLIC PATH DIVERSION ORDER 2019**

On the 16<sup>th</sup> July 2019 the Vale of Glamorgan Council confirmed the above Order made under section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to divert the following public footpaths; N<sup>o</sup>.336 Llantrisant running from Coed Gellihir Isaf (NGR 303718 180266) to the parish boundary west of Pantauquesta Farm (NGR 303771 179837) to a line running from Coed Gellihir Isaf (NGR 303718 180266) to the parish boundary (NGR 303811 179835), N<sup>o</sup>.339 Llantrisant running from Pantauquesta Farm (NGR 304003 179902) to the adopted highway (NGR 304371 180027) to a line running from south of Pantauquesta Farm (NGR 304057 179801) to the adopted highway (NGR 304384 179963), N<sup>o</sup>.36 Pendoylan running from north-west of Cefn Llys (NGR 303947 179528) to Fforest Fach Farm (NGR 303641 179760) to a line running from north-west of Cefn Llys (NGR 303947 179528) to Fforest Fach Farm (NGR 303641 179760) and N<sup>o</sup>.37 Pendoylan running from Fforest Fach Farm (NGR 303764 179759) to the parish boundary (NGR 303771 179837) to a line running from the access road leading to Fforest Fach Farm (NGR 303902 176699) to the parish boundary (NGR 303811 179835), as set out in the Schedule and shown in the Order map.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at the Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT during normal office hours. Copies of the Order and map may be bought there at a price of £4.50.

This Order comes into force on 16<sup>th</sup> July 2019, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 8<sup>th</sup> August 2019 make an application to the High Court.
