PUBLIC PATH CREATION ORDER 2025

This Order is made by the Vale of Glamorgan Council ("the Authority") under Section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that, having regard to the matters set out in Section 26(1), there is a need for public bridleway over the land to which this Order relates, and that it is expedient that the path should be created.

BY THIS ORDER

1. The public right of way over the land situated at Whitehall Farm, Wenvoe shown by a bold broken line on the map contained in this Order and described in Part 1 of the Schedule to this Order, shall be created after 28 days from the date of confirmation of this Order.
2. Notwithstanding this Order any statutory undertaker having apparatus in, on, over, along or across the land referred to in paragraph 1 for the purpose of carrying on their undertaking shall have the same rights in respect of the apparatus as they had immediately before the date on which the bridleway was created.
3. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 2 of the Schedule.

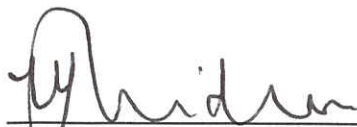

A – B – C – D – E Bridleway Wenvoe No.72	Commences at its junction with Footpath No.30 Wenvoe at point A (NGR 311911 173302) and proceeds westwards passing to the south of the Whitehall Quarries perimeter fence to point B (NGR 311664 173290). The path turns north-westwards to a gap in the field boundary at point C (NGR 311662 173292) then continues westwards parallel to the northern boundary of the farm access track to a bridle gate at point D (NGR 311565 173273) before turning south-westwards to terminate at point E (NGR 311558 173268).	410 metres	3 metres
