Note from the Chair

As I am sure you are sick of hearing, these are extraordinary times. The effects of the pandemic and rapidly changing events are a huge challenge. Our schools are at the forefront, and we need to recognise how much hard work has been done by Staff, Governors, and the Officers in the Vale of Glamorgan's Education Department.

Learning and Culture Scrutiny Committee at its first meeting following Lockdown in September received a heartening presentation on the way schools in the Vale have responded to the pandemic. The support for vulnerable pupils is particularly impressive. Thousands of free school meal vouchers, hundreds of laptops and MiFi devices provided very quickly so pupils could continue their learning from home.

It is interesting to note the difference in approach with our neighbours in England. Because Welsh Government had already invested heavily in its centralised IT system - Hwb - and global software licences, it meant that home learning in Wales had a head start. Even my three-year-old twin grandchildren who are at nursery school have Hwb email accounts and were receiving lessons via Google Classroom

Pupil Inclusion Update

There has been two recent publications that Governors should familiarise themselves with. The first one is an update on Exclusion from schools and Pupil Welfare units Nov 2019

This publication provides guidance on exclusions and appeal procedures for both mainstream schools and PRU's (Pupil Referral Units)

Under section 52(4) of the Education Act 2002, Head teachers, teachers in charge of a PRU, **Governing bodies**, LA's and independent appeal panels must **by law** have regard to this guidance when making decisions on exclusions and administering the exclusion procedures and appeals. This publication includes guidance on alternatives to exclusion which must be looked at before making an exclusion, outlines the responsibilities of the **Discipline committee** within the Governing body and includes model letters for notifying parents of all stages of exclusions.

The second one is a new Pupil registration Guidance Nov 2019 released by Estyn

This report examines pupil registration practices in Wales and in particular the practice of schools taking a pupil off its roll completely without the use of formal permanent exclusions (off rolling) and a school changing the registration status of a pupil in yr 10/11 so that a pupils outcomes are not included in schools key stage 4 performance data. There are 9 recommendations which includes ensuring that **Governors monitor pupil movements** between years 10 and 11. Its also provides questions that a Governing body should be asking to support the **monitoring and evaluation of pupil progression** following the completion of PLASC.

Fixed Penalty Notice (FPN)

FPN's can be used when school intervention to increase attendance is not successful. The Head Teacher authorises this request. Parents are initially sent a warning letter, with a short, specified monitoring period during which the pupil must attend daily. If this is successful, no penalty is given. Where there are unauthorised absences incurred during the monitoring period a financial penalty of £60 is given, to be paid within 28 days. If not paid within 28 days the parent has a further opportunity to pay within the next two weeks, but the amount rises to £120.

Once the penalty is paid there is no further EWS involvement.

Please note that a FPN does not result in a Criminal Record, whereas an EWS Prosecution does.

FPN Training

The Education Welfare Service offers training on the use of Fixed Penalty Notices. This has been very useful to schools where the Governing Body is unsure about the procedure. The training provides a clear and concise understanding of the process as a school attendance management tool.

The training is free and there is no obligation for schools to use FPNs following the training.

Led by the National Centre for Learning Welsh, the Vale's team piloted new Blended Learning courses, which were offered free during the lockdown, adding 4 extra classes to the timetable with learners joining in from near and far. We met new learners from England, Ireland, Germany and Dubai as well as Barry, Cowbridge and Penarth!



It was a learning curve for all, and many people embraced the new way of attending their lesson at

home whilst sipping their favourite drink. The on-screen contact punctuated the week and created a sense of progress. Despite this success some of the learners longed to be back in our centres so over the summer we embraced the Welsh Government's recommendations and planned a way forward

to include face to face teaching. By increasing ventilation, hygiene and reducing class sizes, Learn Welsh the Vale is leading the way with a

programme which offers three choices to the learner- online only, in class only or blended learning.

These are not the only changes. For three years Vale Council employees and Vale school staff have been funded to learn Welsh. This year we are inviting school governors and foster carers to apply for this support too. We want to help you as you support children and school communities.
