All applicants are required to:

Submit a Disclosure Barring Service (DBS) check in respect of their first application and every three years thereafter.

Produce a medical certificate (required if applying for the first time or if renewing your licence after their 45<sup>th</sup>, 50<sup>th</sup>, 55<sup>th</sup>, 60<sup>th</sup> or 65<sup>th</sup> birthday, then annually after age 65) signed by your own registered general practitioner to the effect that you are physically fit to be a driver of a Hackney Carriage or Private Hire

Vehicle. You should inform your GP that this authority requires taxi drivers to meet the DVLA Group 2 standard of fitness. You are required to meet the cost of any certificate or examination.

Produce their DVLA driving licence for inspection. No taxi licence will be issued without proof of a current DVLA licence. The licence must show the same address as stated in the application form. In addition, applicants must provide the DVLA 'Check Code' authorisation for the Council to access your driving record.

Pass a Knowledge Test prior to the first grant of a licence.
