1 APOLOGY FOR ABSENCE -

This was received from Councillor Anthony Ernest.

2 DECLARATIONS OF INTEREST -

No declarations of interest were received.

3 ELECTION OF MAYOR -

It was moved by Councillor Marshallsea and seconded by Councillor Loveluck-Edwards that Councillor Aviet be elected Mayor.

It was moved by Councillor Carroll and seconded by Councillor Charles that Councillor Godfrey be elected Mayor.

On the matter then being put to a vote it was

RESOLVED – T H A T Councillor J. Aviet be elected Mayor of the Council for the ensuing Municipal year.

The newly appointed Mayor made and delivered to the Chief Executive the Statutory Declaration of Acceptance of Office, was invested by the outgoing Mayor with the Chain of Office and took the Chair.

4 APPOINTMENT OF DEPUTY MAYOR -

It was moved by Councillor Sivagnanam and seconded by Councillor Neil Thomas that Councillor Penn be elected Deputy Mayor.

It was moved by Councillor Carroll and seconded by Councillor Charles that Councillor Godfrey be elected Deputy Mayor.

On the matter then being put to a vote it was

RESOLVED – T H A T Councillor E. Penn be appointed Deputy Mayor of the Council for the ensuing Municipal year.

The newly appointed Deputy Mayor made and delivered to the Chief Executive the Statutory Declaration of Acceptance of Office, was invested with the Chain of Office and took the Chair.

5 MAYOR'S ADDRESS –

As the new Mayor for the Vale of Glamorgan, Councillor Aviet thanked Councillors Marshallsea and Loveluck-Edwards for their nominations and kind words.

She stated that it was an honour and a privilege to be able to represent the Vale of Glamorgan and that she was proud of the Vale of Glamorgan's beautiful beaches, parks, and countryside and of the people in all their diversity.

The Mayor drew attention to the issues of homelessness, family breakdown, domestic abuse, sudden illness, disability, hidden disability, addiction, redundancy, post-traumatic stress disorder, isolation, loneliness, and bereavement stating that these were all things which could touch people's lives at any time.

In her term in office, she hoped to convey two messages throughout the Vale of Glamorgan which were to have pride in where we lived and to have empathy for others.

The Mayor concluded by advising that her Consort for the year in office would be her friend, Mr. Brian Morris, and her Pastor would be Rev. Cannon Pat O'Gorman.

6 VOTE OF THANKS TO RETIRING MAYOR AND RETIRING MAYOR'S ADDRESS –

The Mayor took the opportunity to thank the retiring Mayor Councillor Lloyd-Selby for the manner in which she represented the Council during her year in office and in Chairing the Full Council meetings. On behalf of all the Members of the Council, officers and the residents of the Vale of Glamorgan, she also thanked Councillor Lloyd-Selby for her commitment to civic duties and for her hard work and dedication in a particularly challenging period.

At every opportunity the Mayor said she was aware that Councillor Lloyd – Selby had thanked all the people who had supported those in need and who had given their time freely to provide care and friendship.

The Mayor wished Councillor Lloyd-Selby and her husband Mark all the best in the future and that she was honoured to follow in the role that Councillor Lloyd – Selby had undertaken with grace and she hoped that she could discharge the duty with the Council's support as competently as Councillor Lloyd-Selby had.

The retiring Mayor congratulated Councillor Aviet and the Deputy Mayor on their election to office and informed the Council that she had had a busy and enjoyable year as Mayor and thanked all who had supported her. First and foremost she thanked her husband Mark who had done such a brilliant job as consort and who had been always by her side.

The retiring Mayor also thanked the Mayor, as her Deputy Mayor and consort Brian Morris for supporting the events she had been unable to attend during the year and to her Chaplain Pastor Phil Morgan whose prayers and support had been invaluable to her.

Councillor Lloyd-Selby also extended her very grateful thanks to staff in the Democratic Services team who had done a fantastic job in advising and supporting her particularly through the requirements and responsibilities which had arisen following the death of the late Queen Elizabeth stating that the Council was fortunate to have such hard working and skilled officers.

In commenting on her year, which she said had been a historic one, she had had the privilege of leading events on behalf of the Vale to mark the death of the late Queen Elizabeth II and the proclamation of King Charles III, as well as recognising the debt owed to veterans and those currently serving through events such as Armed Forces Day, Merchant Seaman Sunday and more recently holding a minute's silence to mark a year since Russia's barbaric invasion of Ukraine.

The retiring Mayor stated that for her the role of Mayor was about service, and that it had been her pleasure to support community events across the Vale and in particular to meet so many wonderful volunteers who gave their time selflessly serving people across the County. Whether its keeping watch to ensure we're safe at sea, providing food parcels to those in financial crisis, giving children and young people wonderful opportunities through scouting and guide groups, sports activities, fundraising to support charitable activities to name but a few their commitment she said to serving others was both humbling and inspirational.

The Mayor's Foundation had also been able to support 30 groups with funding in her year of office and that she was grateful to all those who had made her welcome over the last year and given her an opportunity to share in a small way in the wonderful work being done.

The retiring Mayor concluded by wishing the Mayor a successful and enjoyable year in office.

7 EXECUTIVE ARRANGEMENTS – CABINET MEMBERSHIP AND PORTFOLIOS (CX) –

Section 4.10.1(f) of the Constitution "Council Procedure Rules - Annual Meeting of the Council" provided that the Annual Meeting would be told by the Leader of the names of Councillors chosen to be Deputy Leader and the number and names of Members to be appointed to the Cabinet and their portfolios / responsibilities, together with the Leader's confirmation that, as part of their portfolios, Cabinet Members would be designated as the Council's "Champions".

Section 5.2 of the Constitution "Form and Composition of the Executive" provided that the Cabinet would consist of the Leader of the Council and at least two, but not more than nine, other Councillors appointed to the Cabinet by the Leader.

The report recommended that the role of the following "Champion Roles" continued to be undertaken by the position-holder indicated:

- Scrutiny Champion Chair of the Scrutiny Committee Chairs and Vice-Chairs Group;
- Member Development Champion Chair of the Democratic Services Committee.

In presenting the report and the supplementary information the Leader commenced by advising that it was with sadness that Councillor Margaret Wilkinson had informed her that she intended to step back from her Cabinet portfolio role to focus on her health. The Leader took the opportunity to thank Councillor Wilkinson for her stalwart service in the Cabinet role and advised that that position would remain vacant with portfolio responsibilities being split between herself and Councillor Gwyn John until further notice.

A requirement existed, under the Local Government (Wales) Measure 2011, regarding the allocation of Scrutiny Committee Chair positions. In essence, any Group, or Groups, represented on the Cabinet were entitled (when taken together) to a proportion of Scrutiny Committee Chair positions equivalent to their total number of seats (when taken together) on the Council. Once this calculation had been done, the remaining Scrutiny Committee Chair positions become the "property" of the non-Cabinet Groups (again, to be allocated proportionate to the total number of seats held by the respective Groups on the Council).

Section 7 of the Council's Constitution set out the Terms of Reference, general role and specific functions of the Scrutiny Committees, a copy of which was attached at Appendix B to the report. The membership of the Scrutiny Committees had been circulated prior to the meeting as Supplementary Information based on information provided by Group Leaders.
