Executive Summary:

- Whilst there is no statutory duty on Councils to provide public conveniences, Welsh Government has placed a responsibility on all local authorities in Wales to produce a Local Toilet Strategy by 31st May 2019.
- An officer working group was established to produce a Strategy and a number of consultation exercises have been undertaken.
- The Strategy was drafted bearing in mind all current factors, including, but not limited to, the Council's financial position and the need to retain the most used toilets.
- The Strategy together with a Management Action Plan is appended to the Report.
- Cabinet will receive further reports as necessary relating to the Management Action Plan.

Recommendations

- 1. That Cabinet approves in principle the draft Toilet Strategy (contained in Appendix A to this Report).
- 2. That Cabinet refers the draft Toilet Strategy to the Scrutiny Committee (Environment and Regeneration) Scrutiny for its consideration.
- **3.** That pursuant to recommendation 2, above any comments from Scrutiny Committee (Environment and Regeneration) are further considered by Cabinet prior to approving the final version of the Toilet Strategy.
- **4.** That pursuant to recommendations 1 to 3, above, the final version of the Toilet Strategy is circulated to all Town and Community Councils and a copy of the final Strategy is presented to the Community Liaison Committee
- **5.** That Cabinet receives further update reports on the Strategy relating to the implementation of the Management Action Plan.

Reasons for Recommendations

1. To obtain Cabinet's approval in principle of the draft Toilet Strategy.

2&3.

To enable the Strategy to be considered by the Scrutiny Committee and its comments considered by Cabinet before a final version is approved.

- **4.** To ensure that all relevant partners are fully informed on the Toilet Strategy
- **5.** To ensure the requirements of the Management Action Plan are met.

1. Background

- 1.1 There is no statutory duty for local authorities in Wales to provide public conveniences. As a non-statutory service at a time of austerity there is clearly a risk that Councils could reduce or even discontinue public convenience provision as financial pressures increase. However, any decisions taken on the provision of public conveniences must be appropriately considered.
- Part 8 of the Public Health (Wales) Act 2017 requires local authorities to publish a local Toilet Strategy by 31st May 2019 for their own area. Earlier reporting on this issue has not been possible, and the publication deadline has now passed. Officers have however written to Welsh Government to advise of the position.
- 1.3 The Strategy must be made available and published on the Council's website.

 There is no requirement for the Strategy to be presented to Welsh Government for approval.
- 1.4 The Council presently operates a number of public toilet facilities in both town centre and tourism locations. The Strategy provides an opportunity to look at this provision as well as examining other options for the provision of publically

- accessible facilities. As such, the Strategy refers to toilets in both public and private ownership.
- 1.5 The aim of a 'Toilet Strategy' is to ensure that each local authority in Wales assesses the needs of its communities in relation to toilet provision, and takes a strategic and transparent approach to meet that need.
- 1.6 Issues such as the accessibility, cleanliness, location of publically accessible toilets needs to be considered within the Strategy. Appropriately located facilities are recognised as being key for tourism, town centre development and leisure activities and can provide both health and economic benefits.
- 1.7 Whilst the provision of public use toilets matter to everyone they are even more important to certain groups such as older people, people with disabilities, people with certain medical needs, children and young families. Poor publically accessible toilet provision can also have a negative impact on certain groups, as it can reduce confidence that adequate facilities are available for use.

2. Key Issues for Consideration

- 2.1 Attached at Appendix B is the Report of Consultation which received 1040 responses. The main findings from the consultation include information regarding usage of each public toilet, public opinion regarding alternative methods of toilet provision, suggestions of how to improve existing facilities and ideas for cost savings.
- 2.2 Results from the consultation show usage levels of all public toilets. The four most frequently used toilets in the Vale of Glamorgan are located at the Beach huts at Barry Island Promenade, the Library in Barry, Cosmeston Country Park Visitor Centre and Porthkerry Country Park. The four least used toilets, in descending order are Park Crescent in Barry, Court Road Multi Storey Car Park, Harbour Road Car Park and Thompson Street, Barry.
- 2.3 Regarding the possibility of charging to use public toilets, 49% of respondents stated that they would be willing to pay. 38% of respondents were willing to pay 10p, 47% 20p, 3% 30p, 10% 50p and 2% £1.
- 2.4 The main suggestions from the consultation were to improve existing toilet facilities, improve cleanliness, modernise and improve facilities, and amend or extend opening hours.
- 2.5 Ideas for cost savings associated with the provision of public toilets from the consultation included, implementation of charges or voluntary charges, improve efficiency, implementation of a community toilet scheme and rationalisation of the Councils toilets.

- 2.6 The Business Survey's main findings (16 responses) were regarding the importance of public toilets and willingness of businesses to allow non-customers to use their facilities. 63% of responses stated that having public toilets in their area is very important and 31% said important. Over two thirds, (69%) stated that their business would be adversely affected if there were fewer toilets in their area. 75% of respondents stated that they do not provide toilet facilities for their customers and 73% said that they would not be willing to let non-customers use their facilities. Two businesses stated that they would be willing for their company to be included on the Council Toilet facility directory.
- 2.7 Following detailed consideration of the questionnaires and face to face consultation at a meeting of the Vale 50+ Forum, attached at Appendix A is the Vale of Glamorgan Toilet Strategy. The Strategy comprises sections setting out the aims of the Strategy and its scope. The locations of toilets across the Vale of Glamorgan are also mapped. The Strategy has been drafted in house by council officers following an audit of existing provision.
- 2.8 The Toilet Strategy has a detailed Management Action Plan at Section 3 (paged 15 to 17) that contains 11 actions. Many of these actions link to the Council's Reshaping Programme and acknowledge the challenges of continuing to provide good quality services whilst reducing costs. Whilst recognising the importance of public toilets the Strategy does recommend rationalising current provision of Public Toilets whist retaining toilets at all four main town centres in the Vale of Glamorgan and at key coastal areas. The Strategy also recommends that the Council continue to discuss with businesses the potential of sharing facilities and the possibility of sponsorship at key locations such as Barry Island and Penarth Seafront. In the same way, the Strategy acknowledges that the Council will need to discuss with Town and Community Councils the merits of retaining public toilet provision in certain locations and whether a partnership arrangement is appropriate in ensuring that provision can be retained. Further action points include condition surveys of all toilet buildings and the potential to redevelop existing facilities into other uses with the possibility of retaining some toilet provision, where necessary and appropriate. The need to review opening hours and the awareness of the location of public toilets is also identified as a priority. The challenges associated with the strategy, particularly with reference to the needs of the vulnerable and elderly, are significant and further review will be required in the future, as resources are expected to continue to reduce.
- **2.9** An Equality Impact Assessment to accompany the Strategy has been prepared and can be found at Appendix C.

3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

3.1 Long Term - The Toilet Strategy has adopted the long term needs of the Vale of Glamorgan in regards to the future provision of toilets in the area.

- 3.2 Collaboration As part of the consultation process the possibility of advertising the availability of other toilets within key locations which the public can access has been investigated. Further efforts, as recommended in the Strategy, will be made to expand the network of toilets accessible to the public.
- 3.3 Involvement Engagement with the public and stakeholders, such as large businesses with accessible toilets, has been an integral aspect in the development of the Strategy. We have sought to take account of people's opinions whilst also being realistic as regards future resources being available for the provision of the services.
- 3.4 Prevention The proposals contained within the Strategy seek to ensure that public toilets remain available in areas of demand, enabling residents and visitors to access facilities. A lack of publically available toilets can act as a barrier to some people from visiting areas and lead to social isolation. The Strategy seeks to consider the provision of toilet facilities in this context.
- 3.5 Integration The provision of public toilets is fully recognised as having an impact on the ability for people live independent lives. In assessing future provision the needs of individuals, as guided by the wellbeing objectives the Council have set, have been carefully considered to ensure key locations remain accessible for all. This will have an impact on the well-being objectives of other organisations, such as Public Health and the University Health Board.
- 3.6 The Toilet Strategy contributes to a number of the Council's well-being objectives and therefore the national well-being goals. The Strategy will contribute to An Active & Healthy Vale: Safeguarding those who are vulnerable and promoting independent living and encouraging and promoting active and healthy lifestyles. The Strategy will also support actions being progressed within the well-being objective, An Inclusive & Safe Vale: Reducing poverty and social exclusion. The Strategy also makes links with An Environmentally Responsible and Prosperous Vale: promoting regeneration, economic growth and employment.

4. Resources and Legal Considerations

Financial

4.1 The Strategy recommends at Management Action 10 and 11 (section 3) to consider the rationalisation of the current provision of toilets operated by the Council. It also seeks in the medium term to investigate the potential of redevelopment of existing toilet blocks in the Vale to examine whether there are alternative uses which could generate income whilst maintaining accessible toilet facilities. These matters will be the subject of separate reports.

Employment

4.2 There are no immediate employment implications associated with this report.

Legal (Including Equalities)

- 4.3 Part 8 of the Public Health (Wales) Act 2017 requires local authorities to publish a local Toilet Strategy by 31st May 2019 for their own area and for the Strategy to be available on the Council's website.
- 4.4 An Equal Impact Assessment has been undertaken and can be found at Appendix C to the report. The assessment shows that there are no unacceptable adverse effects on the protected characteristics covered by the Equalities Act that have been identified through the assessment process. Regarding the physical and mental health of respondents of the consultation survey, 21% stated that they are limited a little and 6% limited a lot. 69% of respondents said that they are not limited and 4% preferred not to say.



1 Introduction

Both residents and visitors to the Vale of Glamorgan depend on the provision of accessible toilet facilities for the enjoyment of their visit. For some individuals and families, toilets can make an impact upon the comfort and overall experience of the area that they see as a desirable place to visit.

Having clean and well located toilets is vitally important for public health. Their positioning can influence and encourage people to socialise and take part in physical exercise, which brings benefits to the local economy. On the other hand, a shortage of public toilet facilities can cause a detrimental impact on a person's health and contribute to a negative outlook upon the area in which they are visiting.

The provision of toilets affects a whole range of issues from public health to transportation, and from crime prevention to economic development. It is an important aspect in delivering an environment that is accessible for all who choose to enjoy it.

Toilets are vital for those who spend their time away from home or those without a fixed permanent workplace, but they can be even more important to certain groups of people who rely more on toilets. These groups of people can include the elderly, people with disabilities, people with medical problems, women, children and families. Poor provision of toilets can disproportionately affect these groups of people and ultimately affect their decision to visit certain places or to stay at home. As a result, large parts of the active community can become isolated and lose independence in daily life.

The need for accessible toilets is likely to increase as the population of the Vale is growing with new housing developments taking shape, an ageing population and tourism figures projected to continue to rise. During the period between 2006 and 2017, visitor numbers has increased by 1.1% per year/ visitor numbers has increased by 11.8%. This is also reflected in the number of visitor days, which has increased, by 1.0% per year. Therefore the aim of this Strategy is to contribute towards securing an adequate provision of toilets for wherever people live, work or visit in the Vale.

On 31st May 2018, Part 8 of the Public Health (Wales) Act 2017: Provision of Toilets came into force, which places a duty on each local authority to publish a toilet strategy. The key for the Strategy is to engage with users of public toilets and potential providers. It is the responsibility of local authorities to:

- assess and analyse the need for toilet provision within the area
- plan to meet those needs
- produce a local toilet strategy; and
- review the strategy, update and publicise revisions.

The deadline for local authorities to publish their strategy is 31st May 2019. The local authority does not have a duty to provide or maintain public toilets directly but it does have other responsibilities, which include the responsibility to:

- assess the need for toilet provision in communities,
- plan to meet those needs.
- produce a toilet strategy; and
- review, update and publicise the strategy and its revisions including statements of progress.











To help carry out sustainable development, the Well-being of Future Generations (Wales) Act 2015 outlines five ways of working to deliver their duty of the act. These include:

- looking to the long term so we do not compromise the ability of future generations to meet their own needs;
- taking an integrated approach;
- working with others in a collaborative way to find shared sustainable solutions;
- involving a diversity of the population in the decisions affecting them; and
- acting to prevent problems from occurring or getting worse.

Due regard has been made to the above five ways of working when preparing, reviewing, consulting on and publishing this strategy.

The key prevention aims of this local toilets strategy are to:

- Identify key toilet facilities.
- Identify facilities at risk of being lost to a location, and ways to preserve their use; identify alternative provisions if facilities must close.
- Identify additional facilities that can be brought into wider use to supplement existing facilities or as a replacement for those that have been lost; and
- Identify opportunities for creating new facilities to modern, inclusive specifications.

1.1 The Aim of the Strategy

The main aim of the Strategy is to provide clean, safe and accessible toilets for both residents of, and visitors to, the Vale of Glamorgan in areas where a need has been identified.

1.2 How to achieve the aims of the Strategy

The Strategy aim is met by:

- Identifying the level of current provision of public toilets.
- Involving the local community and key stakeholders by gathering feedback via questionnaires, emails and meetings.
- Publishing and releasing both public and businesses specific questionnaires.
- Analysing the results and feedback received.
- Identifying needs and gaps in provision using the information collated.
- Considering various factors such as population statistics and demographics.
- Reviewing existing provision via both Local Authority, Town Councils and NHS information.
- Liaising with other sources such as private enterprises, businesses etc. to consider public use of their facilities.
- Following scrutiny, adopting a strategy to increase awareness of public toilets and their locations.











1.3 Developing the Strategy

A wide range of Council's departments were invited to take part in developing the Strategy so that it was possible to achieve the Strategy's aims. By consulting the public, local businesses, community groups and other public bodies as well, a greater understanding was gained regarding current provision and to the specific needs for public toilets.

Both a public and a business consultation took place between 9th November 2018 and 8th February 2019. The main methods to engage and attract respondents included:

- Online, via the Vale of Glamorgan Council website, social media and through partner organisations' websites
- Notification via the email update reminder service
- Face to face discussions at the 50+ Forum
- Electronic and paper questionnaires open to all
- Consulting/ engaging with businesses located in town centre or tourist area and inviting them to complete the survey

A total of 1040 responses were received from the public and 16 from businesses. All results have been included in the analysis and comments listed in the Consultation Report.

The business survey requested respondents to express their opinion and willingness to allow the use of their toilets for non-customers and to be mapped on-line, smartphone apps and to display a sticker.

1.4 Corporate Plan 2016-20 and Financial Reshaping

The Vale of Glamorgan Council serves one of Wales' most diverse local authority areas. It contains areas that are attractive, vibrant and thriving. The Toilet Strategy can contribute to the Council's Corporate Plan of 2016-20. The Plan sets out its values and professional behaviours as:

- Ambitious Forward thinking, embracing new ways of working and investing in our future.
- Open Open to different ideas and being accountable for the decisions we take.
- Together Working together as a team that engages with our customers and partners, respects diversity and is committed to quality services.
- Proud Proud of the Vale of Glamorgan: proud to serve our communities and to be part of the Vale of Glamorgan Council.

The Strategy aims to improve access and provision of public toilets, which is in line with the four well-being outcomes:

- An Inclusive and Safe Vale.
- An Environmentally Responsible and Prosperous Vale.
- An Aspirational and Culturally Vibrant Vale.
- An Active and Healthy Vale.

The Public Toilet budget for financial year 2019/20 is £324,000. The Council is required to make efficiency savings of £3.7m in 2019/20, and an element of this needs to be found in relation to public toilets. Consequently, alternative ways of providing some public toilets will need to be considered.











1.5 Historic and current provision of public toilet facilities in Vale of Glamorgan

Due to the increasing pressure on budgets and resources, the provision and maintenance of public toilets is a challenge for the Council. Across the authority there are 23 sets of Council owned public toilets. These toilets need to be considered for rationalisation as part of the Council's Medium Term Financial Plan, and to assist in addressing a savings requirement of £3.9m faced by the Council for the 2019/20 financial year. Over the last decade, the number of local authority run traditional public conveniences in the UK has decreased and the trend is that local communities manage some of these types of toilets.

The specific funding from Welsh Government, which offered a Community Toilet Scheme Grant that was administered by local authorities in 2014/15, was transferred to WG Revenue Support Grant. The Community Toilet Scheme, which offered annual recompense payment of up to £500 to businesses who opened their toilets to the public, has now ceased to exist.

1.6 Public toilets

Public toilets are freely available for use by the general public and are normally owned, maintained and delivered by local authorities.

Detached toilets or toilet blocks are regarded as the most traditional form, however due to high maintenance, anti-social behaviour and negative perception, a different approach is needed in some cases. Cooperative provision of public toilets within existing buildings can allow continued efficient and safe provision.

Commercial premises have a role to play in the provision of accessible toilets for both their customers and for the wider public. As a result, it is necessary to engage with partners to find businesses who are willing to have publicly accessible toilets.

1.7 Council-owned Toilets

1.7.1 Stand-alone - Council managed

These toilets are commonly known as a traditional toilet block and are often located in parks and open spaces. They can be isolated from other amenities and due to their detached nature from other buildings, can be susceptible to anti-social behaviour, crime and vandalism, and therefore, are often high maintenance assets.

1.7.2 Other Council run toilets

Public toilets are also provided in other spaces such as libraries, leisure centres, country parks and beaches. These spaces play an important role in the toilet provision. <u>Section 5</u> contains details of all Council owned toilets.

1.8 Commercial, business and other organisations toilets

Most commercial and retail business toilets are primarily for the use of their customers. Whilst some business owners recognise that non-customers using their toilets can increase footfall and lead to people purchasing goods, most premises that aren't part of a Community Toilet Scheme are generally reluctant to offer the use of their toilets without a purchase.











Other local government bodies, such as Town Councils provide public toilets that, for example, can be located in the grounds of cemeteries or in Town Halls that they own.

1.9 Survey Themes

Public Survey

The main findings from the Public Survey include information regarding usage of each public toilet, public opinion regarding charging, suggestions of how to improve existing facilities and ideas for cost savings.

According to the rankings of the toilet usage from the consultation, the 4 most regulary used toilets are at the Beach huts at Barry Island Promenade, the Library in Barry, Cosmeston Country Park Visitor Centre and Porthkerry Country Park. The 4 least used toilets, in descending order are Park Crescent in Barry, Court Road Multi Storey Car Park, Harbour Road Car Park and Thompson Street, Barry.

Regarding charging to use public toilets, 49% of respondents stated that they would be willing. 38% of respondents were willing to pay 10p, 47% 20p, 3% 30p, 10% 50p and 2% £1.

The main suggestions to improve existing toilet facilities included, improve cleanliness, modernise and improve facilities, and amend or extend opening hours.

Ideas for cost savings associated with the provision of public toilets included, implementation of charges or voluntary charges, improve efficiency, implementation of community toilet scheme and rationalisation of the Councils toilets.

Business Survey

The Business Survey's main findings were regarding the importance of public toilets and willingness of businesses to allow non-customers to use their facilities.

63% of responses stated that having public toilets in their area in attracting visitors to the town is very important and 31% said important.

Over two thirds, with 69% stated that their business would be adversely affected if there were fewer toilets in their area.

75% of respondents stated that they do not provide toilet facilities for their customers and 73% said that they would not be willing to let non-customers use their facilities. Two stated that they would be willing for their company to be included on the Council directory.











2 Toilet locations and mapping the dataset

An important part of this Strategy is to map the locations of all toilets giving information regarding the opening times, accessibility and types of toilet facilities. This information can be promoted and marketed through a smartphone app in which participating premises will also be included.

The British Toilet Association recommends that signs should be fitted on the outside of premises with information such as opening hours, contact information for reporting problems and the specific facilities provided inside, such as whether there is a baby-changing room.

The Council intends to publish a dataset with information on toilet location, facilities etc., on the Council's website. This data will also be submitted into the Welsh Government system and the Lle Geo-Portal where it will be possible to generate nationwide maps based on the data from all Local Authorities. The information could be used by other public sector organisations or for commercial reasons to develop maps and smartphone apps.

The Lle Geo-Portal has been developed as a partnership between Welsh Government and Natural Resources Wales. Lle serves as a hub for data and information covering a wide spectrum of topics, but primarily around the environment. The link to the Lle website is below. http://lle.gov.wales/home

2.1.1 Changing Places

Changing Places are toilets for people with physical disabilities and profound and multiple learning disabilities who require extra equipment and space to allow them to use the toilet safely and comfortably. Each Changing Places toilet provides the right equipment, enough space and a safe and clean environment. Changing Places are different to standard accessible toilets or disabled toilets.







1 Public Survey

The survey ran from 8th November 2018 until 8th February 2019.

There were 1040 responses to the survey; a copy of the survey is contained at <u>Appendix A</u>. The survey included a number of questions as well as the opportunity to make comments.


Due to the volume of responses, this consultation report summarises the main issues raised but full details of every comment received can be found at <u>Appendix C</u>.

Profile of respondents

The vast majority (92%) of respondents are local residents whilst a small number are local business owners (2%), visitors to the Vale of Glamorgan (2%), local councillors (1%) and 3% selected other.

As part of the survey's Equality Monitoring, respondents were asked a range of questions relating to their age, gender, disability, religion and whether they were pregnant in the last 6 months.

The chart below shows the spread of the age categories of the survey respondents.



50% of respondents are in the age category 55-74 whilst 30% are 35-54, 9% are 75 and over, 8% are 25-34. 1% stated that they are 18-24, less than 1% are under 18 and 2% prefer not to reveal their age.

When asked about physical or mental health, illness or disability which has lasted, or expected to last 12 months or more, 69% of respondents stated that their day-to-day activities are not limited. 21% stated that they are limited a little and 6% limited a lot. 4% preferred not to say.


46% of respondents stated Christian (all denominations) when asked what is their religion. Buddhist, Jewish and Muslim amounted to less than 1% of respondents. 38% stated no religion, 3% stated any other religion whilst 13% prefer not to say.

Regarding gender, 60% of respondents are female, whilst 35% are male. Less than 1% responded stating they are another gender identify and 3% prefer not to say.


Finally, 2% of respondents are currently pregnant or have been within the last year. Whilst 93% had responded no and 5% prefer not to say.

1.1 Survey Results

1.1.1 Toilet general usage




941 (94%) of respondents stated that they use public toilets in the Vale and 60 (6%) said they don't.



Reasons why respondents don't use public toilets include 18 respondents (52%) who stated that they don't need to. Other reasons respondents stated included, unaware of their location (11%), cleanliness (11%), no toilets in my area (9%), toilets are not open (6%) and that respondents try to avoid using them (11%).

1.1.2 Usage levels by toilet



Respondents were asked how often they use 23 different toilets in the Vale of Glamorgan. The most used toilets on a daily basis is the County Library, King Square, Barry with 24 of the 1040 respondents (2.31%) and the least used on a daily basis are Ogmore Car Park, Ogmore by Sea, Beach Road, Dunraven Beach, Southerndown and Italian Gardens, The Esplanade, Penarth with only 5 respondents (0.48%) each.

The Country Library, King Square, Barry is also the toilet with the highest percentage of users on a weekly (11.63%) and fortnightly basis (5.10%). The least used on a weekly basis is Beach Road, Dunraven Beach with 1.44% of respondents and on a fortnightly basis is Thompson Street, Barry with (0.96%).

The most used on a monthly basis is Cosmeston Country Park Visitor Centre with 12.79% and least used is Harbour Road Car Park, Barry (Seasonal) with 1.44% of respondents.

The toilet with the highest percentage that respondents said they used every now and then is Cosmeston Country Park Visitor Centre with 48.65% and least used is Boverton Road, Llantwit Major with only 13.08%.






1.1.3 Charges to use toilets






49% of respondents stated that they would be willing to pay to use a public toilet whilst 51% said that they would not. Of those willing to pay, 70.61% answered q5 to state how much they would be willing to pay. 47% of respondents were willing to pay 20p, whilst 38% were willing for 10p, 10% for 50p, 3% for 30p and 2% for £1.

1.1.4 Usage of non-Council toilets



93% of respondents stated they use public toilets other than Council toilets. Of those that stated they do use non-Council toilets, 88.92% answered q6a to specify location. 44% stated they use toilets in supermarkets, 3% in Café, restauants and pubs etc, 2% in Town centre shops, 2% in Libraries. 49% stated they use toilets in various locations.


1.1.5 Improving existing toilet facilities



The main suggestions to improve existing toilet facilities are to improve cleanliness (24%) and modernise/ improve facilities (20%). Other responses include suggestions to amend/ extend opening hours (8%), improve monitoring/ maintenance (7%), improve provision of toilets (4%), implement charges (3%), improve disabled facilities/ make more accessible (3%), improve advertising & signage (3%) and comments stating importance to keep free for public (5%) and opposition to charging due to issue of finding charge (2%). 6% responded with other suggestions outside of the above categories and 15% had no suggestions.


1.1.6 Cost savings for the provision of public toilets



The main suggestions for cost savings associated with the provision of public toilets included implement charges or voluntary charges (19%), improve efficiency in toilets (16%) or to make other Council related savings (12%). Other responses include implement Community Toilet Scheme (5%), close the least used toilets (4%), offer toilet sponsorship (3%), involve volunteers or Community Service with maintenance (3%) and amend/ shorten opening hours (1%). 14% responded with suggestions related outside of the above categories and 24% had no suggestions.

1.1.7 How did you hear about this survey?



When asked how you heard about this survey, main responses included the VoG Council Website (27%), an E-mail from VoG Council (23%) and VoG Council on Facebook (20%). Other responses include Other Social Media (7%), Word of mouth (6%), Library (2%), Glamorgan Voluntary Service (2%), Local Councillor (2%), VoG Council on Twitter (2%) and Bro Radio (1%). Other responses, which fell out of the above categories, amounted to (6%).

2 Business Survey

Profile of respondents


The survey ran alongside the public survey from 8 November 2018 until 8 February 2019.

There were 16 responses to the survey and a copy of the survey is contained in <u>Appendix B</u>. The survey included responses from a range of businesses from both the Vale of Glamorgan and outside of the authority. The survey asked respondents to leave comments in the last question, which allowed the businesses to express their views.

14 different businesses completed the survey as 3 responses were received from the same business. 7 businesses are from Penarth, 5 from Barry, 1 from Cowbridge and 1 from Cardiff.


2.1 Survey Results

2.1.1 Importance of public toilets




When asked how important is having public toilets in your area in attracting visitors to the town, 10 of the 16 (63%) of the businesses stated that it is very important and 5 (31%) says it is important. 6% of the businesses responded by saying they don't know.

2.1.2 Effect of fewer public toilets




11 of the 16 businesses (69%) stated that in their opinion, their business would be adversely affected if there were fewer public toilets in their area. 2 businesses (12%) said no and 3 (19%) said they don't know.

2.1.3 Toilet usage for customers




4 of the 16 businesses (25%) provide toilet facilities for use by their customers whist 12 (75%) say they don't.


2.1.4 Willingness to allow non-customer to use business facilities, display sign and to be included in Council directory



When asked if there were fewer public toilets in your area, would you be willing to let non-customers use your facilities, 11 of the 15 businesses which answered the question 73% responded by saying No. 2 of the businesses said yes and another 2 responded don't know.



Despite only 2 businesses answering yes to the previous question 9 have answered question 6. When asked if you would be willing to display a sign on the outside of your premises indicating that you would be willing for non-customers to use your toilet, 5 of the 9 (56%) businesses indicating that they wouldn't be willing. 2 businesses responded yes and another 2 stated they don't know.



Despite only 2 businesses answering yes to the previous question 6 have answered question 7. When asked if you would be willing for your company to be included on the Council directory available on their website indicating this, 3 of the 6 businesses (50%) stated no. 2 of the 6 businesses (33%) answered yes whilst 1 (17%) said don't know.

3 Consultation Sessions

Minutes of the Executive Meeting 17th January 2019 – 50+ Forum

An Executive Meeting was held on 17th January 2019 to collect the views and opinions of residents of 50 plus in age. The key findings during the focus group can be summarised as follows:

- Recognition that the service is vital to particular residents, including those elderly and special needs.
- Provision of public toilets for tourists and in seaside resort locations important.
- Both of the above points need to be recognised along with the legislative framework including the Disability and Equality Acts.
- Despite not being statutory to provide from a local authority, many of the members felt public toilets is a "right" for the ageing populace.
- Members raised issue of the closure of the public toilets in the Civic Offices, Barry
 - Members were explained that they had been closed from the public due to continued misuse.
- Members raised issue that an Equalities Impact Assessment (EIA) may be needed if proposals of charging for use of the toilets are implemented due to the varied income demographic of users. Members informed that an EIA would be produced
- Issue of Transgender toilets to be investigated.
- The importance of utilising a range of methods for consultation was highlighted and not just reliance on on-line surveys.

- 8. Due to a broken toilet at home I have used Penarth public loos frequently for the past couple of weeks. I have never been the only person in the ladies loo on any occasion. Our public loos are a lifeline to Penarth residents and visitors alike.
- 9. The public toilets are an essential service to the town and I am pleased to see how well they are currently maintained. Many restaurants, cafes and public houses can provide toilet facilities but this is for their customers not the general public. If we want visitors to spend time in the town we need to accommodate their needs, local shops will only thrive if visiting our town is a pleasure. We cannot offer our toilet facilities at Artisans Corner as they are situated in the basement below the shop which is our private storage area and would put our artwork and general stores at risk of damage or even theft. Thank you for consulting us in your decision, it is appreciated and I hope our views will be taken into consideration
- The Penarth town toilets should be seen as a positive addition to Penarth. Easy access for the disabled, mothers with pushchairs, and dog owners. Many of which would have problems accessing shop toilets. Artisans Corner cannot ever allow customers/town visitors access to our toilets as they're situated downstairs beyond our open stock area. Things would get stolen. Only one person is in the shop selling at a time. Very often, when getting off the bus at 8.15, my bus driver runs ahead of me to use the facilities, as no shops are open at that time anyway, and he's travelled from Bridgend to start his shift. Also, visiting delivery vans, taxis, and motorists need to stop there and do. If you've ever got off a bus in Cardiff center, you'll be hard pressed to find a toilet. Please keep this amenity open, as it's a necessary part of a thriving and welcoming town, Penarth. Port Talbot closed their loos by the railway station 30 years ago. The derelict building is still there. Would this also happen in Penarth?....
- I have already responded to your survey but an important point has been brought to my attention that I feel should be passed on to you for consideration. Many of the delivery driver take advantage of our public toilets when delivering our supplies. They are often travelling all day and need to have access to toilets on a regular basis. This is not only a social need but an essential requirement for their health. I wasn't aware of this fact until I was told this story by a friend working in a civilian capacity for the police. He was giving one of the senior police officers a lift and was quite surprised when the officer asked him to wait while he visited the gents before they set off. He told my friend everyone should do this. Apparently if you have an accident while driving you are more at risk of rupturing your bladder if it is full and this cannot be always be repaired. I would hate to think our delivery drivers health and safety might be put at risk by closing the public toilets. I hope I am able to add this to you information

What is the purpose of the proposal?

The purpose of this proposal is to make changes in the way that we deliver public conveniences in the Vale of Glamorgan.

- To consolidate the number of council ran public connivances in the Vale of Glamorgan
- Transfer a number of public conveniences to relevant directorates.
- Work with local businesses to provide additional toilet facilities.

Why do you need to put it in place?

On 31 May 2018, Part 8 of the Public Health (Wales) Act 2017: Provision of Toilets came into force which places a duty on each local authority to publish a toilet strategy. The key for the strategy is to engage with users of public toilets and potential providers. It is the responsibility of local authorities to:

- assess and analyse the need for toilet provision within the area

- Review the strategy, update and publicise revisions.

The deadline for local authorities to publish their strategy is 31 May 2019. The local authority doesn't have a duty to provide or maintain public toilets directly but it now has other responsibilities which include the responsibility to:

- plan to meet those needs,
- produce a toilet strategy; and
- Review, update and publicise the strategy and its revisions including statements of progress.


