<p>Executive Summary:</p> <ul style="list-style-type: none"> <li>To seek Cabinet approval to grant delegated powers to the Operational Manager, Democratic Services in liaison with the Leader of the Council to identify and nominate three new Members to replace Councillors C.A. Cave, R. Nugent-Finn and L.O. Rowlands to represent the Council on Cardiff and Vale Community Health Council (CHC) until the Local Government Elections, May, 2022.</li> </ul>	

## **Recommendation**

1. That Cabinet be requested to grant delegated powers to the Operational Manager, Democratic Services, in liaison with the Leader of the Council, to identify and nominate three new Members to represent the Council on the Cardiff and Vale Community Health Council.
2. That, where legally possible, attendance at meetings of organisations to which a Member has been nominated or appointed by the Council be classed as an approved duty for which travelling and subsistence allowances are payable, in accordance with the Council's scheme.

## **Reason for Recommendations**

1&2 To ensure continuity of representation by the Council on the Cardiff and Vale CHC.

### **1. Background**

- 1.1 Historically, the Council has appointed / nominated representatives to sit on a large number of Outside Bodies / Joint Committees.
- 1.2 As far as the Cardiff and Vale CHC is concerned, the level of commitment required has led, over many years, to nominated Members eventually being unable to devote the time required to undertake the role. This is an issue which has arisen in a number of Community Health Councils across Wales over past years.

### **2. Key Issues for Consideration**

- 2.1 The Chief Officer of the Cardiff and Vale Community Health Council (CHC) has written to the Council (letter attached at Appendix A) drawing to the Council's attention that Councillors C.A. Cave, R. Nugent-Finn and L.O. Rowlands have not participated in or engaged in any CHC activities for some time. Accordingly, the Chief Officer of the CHC has formally requested the Council to appoint three new representatives as soon as possible.
- 2.2 It is proposed that all such appointments should run for the life of the Council i.e. until the local government elections in 2022. This would obviously be subject to the agreement of the relevant body to which Members have been appointed.
- 2.3 Following the formal request it is suggested that delegated powers be granted by Cabinet to the Operational Manager for Democratic Services in liaison with the Leader of the Council to identify three new Members to represent the Council.

### **3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?**

- 3.1 Appointments of Members to Outside Bodies allows for planned integration, involvement and collaboration opportunities and transparency.
