# C206 WHISTLEBLOWING: STAFF SURVEY RESULTS AND ANNUAL REPORT (REF) –

The reference from Governance and Audit Committee of 12<sup>th</sup> December, 2022 was presented.

The Leader said there had been an interesting discussion at the meeting, including the launch of the Speak Out Hub, the numbers of reports that were more concerned with the grievance procedure rather than whistleblowing and the use of statistics and percentages.

Recommendation (4) asked that the Chief Executive be requested to ensure that whistleblowing was placed on all Directorate agenda meetings, Head of Service meetings and Team meetings. The Leader said that quarterly whistleblowing meetings were being held across the Council where all issues raised were captured so the Council could learn and improve.

The Leader also added that there was a duty on all Members to report any issues concerning safeguarding.

# C207 PROJECT ZERO UPDATE REPORT (REF) –

The reference from Corporate Performance and Resources Scrutiny Committee of 18<sup>th</sup> January, 2023 was presented.

The Leader said that the term of the current Administration was due to end in 2027 and that the Challenge Plan set out the activities that would contribute to the Council's aim of being net zero by 2030, only three years later. Climate change was difficult to factor into budget setting but was so important as a consideration. There was discussion about carbon emissions in relation to procurement and how the Council needed to be mindful of the services that are procured and their carbon impact.

Councillor Wilson agreed that addressing climate change was a major challenge and that some decisions were currently the subject of consultation with the public and

Scrutiny Committees, e.g. green waste recycling. He encouraged all residents to think about their behaviour going forward, e.g., sustainable use of public transport instead of cars, types of products purchased, etc. He was pleased that the Council had reserves available to continue to tackle the climate change challenge. The Leader referred to Page 9 of the main report which detailed the reserves that had been set aside to support the work on climate change projects.

The Leader said that she would welcome greater detail concerning an integrated public transport system as part of Project Zero and sustainable transport and hoped that the Transport Hub in Barry Docks would be open shortly. Greater use of Photovoltaic panels for solar power on both Council owned public buildings within the Vale of Glamorgan was also being assessed and work undertaken by the Council with suppliers and procurement partners on decarbonisation and sustainability.

C208 AUDIT WALES: VALE OF GLAMORGAN COUNCIL ASSURANCE AND RISK ASSESSMENT (ARA) REVIEW 2021/22 AND THE AUDITOR GENERAL FOR WALES NATIONAL STUDY REPORT ON PUBLIC SECTOR CARBON READINESS FOR NET ZERO BY 2030 (REF) –

The reference from Corporate Performance and Resources Scrutiny Committee of 18<sup>th</sup> January, 2023 was presented.

The Leader said that this was an interesting and wide-ranging report which Corporate Performance and Resources Scrutiny Committee looked at in detail, including the Medium Term Financial Plan refresh, wider challenges of costing and funding decarbonization and delivery of savings targets. Officers from across the Council were working collaboratively to see how to deliver services.

Referring to Recommendation (1) of the reference, the Leader said that the aim of the Council was to meet savings targets in a more targeted way which achieved the savings requested without impacting on services and other key areas of Council business, but that was difficult to achieve. # C209 COST OF LIVING SUPPORT FOR FOOD, WARM SPACES AND OTHER MEANS OF SUPPORT (REF) –

The reference from Corporate Performance and Resources Scrutiny Committee of 18<sup>th</sup> January, 2023 was presented.

The Leader said that there was a cross-Directorate working group which was discussing how different facilities supported residents with warm spaces and food. There had been a misunderstanding at the meeting concerning warm spaces being made available in urban settings, when in fact they were across the Vale of Glamorgan in rural areas and growing in numbers also.

Funding had been available from Welsh Government and discussion was taking place about how to fund such facilities sustainably once that funding comes to an end. The Leader was pleased to note that such spaces were very popular and had also provided safe spaces for young people to go on the evenings.

With regards Recommendation (2) of the reference, it was agreed that any further updates or reports to Cabinet on the Council's response to the Audit Wales Report be referred to the Corporate Performance and Resources Committee.

# C213 PAY POLICY 2023/2024 - (EL/PR) (SCRUTINY - CORPORATE PERFORMANCE AND RESOURCES) -

The Leader presented the report, the purpose of which was to consider and endorse the Council's annual Pay Policy for 2023/24 prior to its submission to Council for approval.

The Leader said that the report would be referred to Corporate Performance and Resources Scrutiny Committee for in-depth discussion. She referred to Section 12 of Appendix A to the report concerning the differential between the top and the bottom of the organisation being quite flat.

Councillor Wilson referred to Section 8.1 of Appendix A to the report which highlighted the progress made in addressing gender pay gaps. Section 7.14 of Appendix A to the report showed almost identical gender profiles, it was good to see that kind of equality and he applauded the Council for working towards that position.

The Leader said she would like to see some benchmarking data in order to compare the position in the Vale of Glamorgan to other Local Authorities but was pleased to see a good balance across senior officer level, Heads of Service and Operational Managers.

This was a matter for Executive and Council decision Cabinet, having considered the report and all the issues and implications contained therein

# C214 STATUTORY CONSULTATION TO EXPAND YSGOL IOLO MORGANWG FROM 210 PLACES TO 420 PLACES FROM SEPTEMBER 2025 - (EAWL) (SCRUTINY – LEARNING AND CULTURE) –

The Cabinet Member presented the report, the purpose of which was to seek Cabinet approval to undertake a statutory consultation to expand Ysgol Iolo Morganwg from 210 places to 420 places from September 2025.

This was a matter for Executive decision.

Cabinet, having considered the report and all the issues and implications contained therein

#### RESOLVED -

- (1) T H A T the Director of Learning and Skills be authorised to undertake a consultation on the proposal to expand Ysgol Iolo Morganwg from 210 places to 420 places from September 2025 starting on 27<sup>th</sup> February, 2023 for a 6-week period ending on the 11<sup>th</sup> April, 2023.
- (2) THAT the report be referred to the Learning and Culture Scrutiny Committee for consideration as part of the proposed consultation exercise.

- (1) To seek Cabinet authority to carry out a statutory consultation in compliance with the requirements of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code 2018 on the proposal to expand Ysgol Iolo Morganwa from 210 places to 420 places from September 2025.

# C215 HOUSING REVENUE ACCOUNT BUSINESS PLAN - (PSHTE) (SCRUTINY – HOMES AND SAFE COMMUNITIES) –

The Leader presented the report, the purpose of which was to present the Housing Revenue Account Business Plan 2023 for approval.

The Leader referred to Paragraph 2.4 of the report and the plan to afford new build and acquisition schemes of £236m over years 1-30. She said that was a good starting point but the Authority was ambitious and it was hoped more could be achieved.

This was a matter for Executive and Council decision Cabinet, having considered the report and all the issues and implications contained therein

#### RESOLVED -

- (1) T H A T the Housing Revenue Account Business Plan 2023/53 (draft) attached at Appendix 1 to the report be approved.
- (2) T H A T the report be submitted to the Homes and Safe Communities Scrutiny Committee for consideration. Should the Homes and Safe Communities Scrutiny Committee make no comment then the Housing Revenue Account Business Plan 2023/53 would be considered approved and submitted to Full Council on 6<sup>th</sup> March, 2023 for approval prior to submission to Welsh Government.

# C216 RESHAPING SERVICES: SINGLE USE SPORTS FACILITIES - (LSW) (SCRUTINY – HEALTHY LIVING AND SOCIAL CARE) –

The Cabinet Member presented the report, the purpose of which was to update Cabinet of progress to date on the transfer of Single Use Sports Facilities and to seek approval to progress further transfers.

The Leader said that previous transfers had worked well, and it was constructive where clubs were managing their own grounds, often making it more cost effective for the club and the Council. She asked if as part of the negotiations with Old Penarthians Rugby Club that Penarth Football Club also be approached to ensure communication between the two clubs regarding shared use of the wider area, which Councillor John agreed would take place.

Councillor John amended the wording regarding Recommendation (6), that Cabinet receives a further report on this matter 'before' 1<sup>st</sup> September, 2023 rather than 'after'.

This was a matter for Executive decision.

Cabinet, having considered the report and all the issues and implications contained therein and noting the amendment to Recommendation (6)

#### RESOLVED -

(1) THAT the significant and positive progress made in relation to single use sports grounds facilities to date be noted.

- (2) T H A T subject to Resolutions (3) and (4),the Director of Environment and Housing, in consultation with the Cabinet Member for Leisure, Sport and Wellbeing, be authorised to negotiate the transfer of the sites detailed in the report namely: Penarth Athletic Club, Old Penarthians Rugby Club, Wick Pavilion, St. Brides Pavilion, Island Marine Football Club, Llantwit Major Football and Cricket Clubs, Vale United Football Club and Barry Rugby Club with the objective of completing transfers by 1st September, 2023.
- (3) T H A T authority be delegated to the Monitoring Officer/Head of Legal and Democratic Services to advertise the proposed disposals in accordance of s123 (2A) Local Government Act 1972 and Regulation 5 of the Playing Field (Community Involvement in Disposals Decisions (Wales) Regulations 2015 where relevant.
- (4) THAT any objections to the land disposals proposed are reported separately to Cabinet for consideration prior to any final decision being taken and that, should no objections be received, matters progressed as detailed in the report.
- (5) T H A T subject to Resolutions (3) and (4), the Monitoring Officer/Head of Legal and Democratic Services in consultation with the Head of Finance/Section 151 Officer and Director of Environment and Housing, be authorised to prepare execute and complete the required leases.
- (6) T H A T Cabinet receives a further report on this matter before 1<sup>st</sup> September, 2023.
