C142 STRENGTHENING OUR COMMUNITIES AND WORK TO TACKLE POVERTY AND THE CURRENT COST OF LIVING CRISIS (REF) –

The reference from Corporate Performance and Resources Scrutiny Committee on 18th October, 2023 was presented.

The Leader said that the Committee considered the four Audit Wales reports, all of which were hugely important and included ongoing discussions about relationships with the Third Sector which had changed over recent years. There had been a query regarding the impact of Council Tax increases and cost of living crisis; the Leader said that the Council was very aware of pressure on local residents and any Council tax increase had therefore been kept to less than half the rate of inflation, keeping the rate low as possible while being aware of the need to deliver services. The Leader also referred to community development work and thanked the many organisations that had delivered 'Warm Welcome' places for their communities last year and that many were doing the same again this year.

C143 FINAL DRAFT VALE OF GLAMORGAN COUNCIL ANNUAL SELF-ASSESSMENT REPORT 2022/23 (REF) –

The reference from Governance and Audit Committee on 23rd October, 2023 was presented.

The Leader said there had been a detailed discussion at the meeting, including a comment that the report was quite accessible in relation to the amount of information contained within it, however at a previous Committee it had been said that the report was complex and difficult to read, which was a matter to be looked into.

In terms of reviewing the Council's Self-Assessment approach, a number of areas had been identified and a widely circulated public summary document would be produced as part of the engagement work which had been informed by both feedback by residents and also Members within Committees on how they would like the Council Self Performance Information to be reported, that could include an easy read version of the report and also bite sized social media posts.

There was also discussion whether or not Brexit should be included in the assessment on balance it was decided that reference should be removed from the Annual Self-Assessment Report.

The Leader referred to the discussion concerning hybrid meetings and said that it remained the aspiration of the Council to embed our use of the integrated hybrid meeting technology to improve participation in local democracy in line with our public participation priorities which remained a key area of focus.

Councillor Williams referred to the challenging situation regarding budget setting that would be subject to much discussion over the coming months and looked forward to constructive discussion at Full Council.

C144 VALE OF GLAMORGAN REPLACEMENT LOCAL DEVELOPMENT PLAN 2021-2036 REVISED DELIVERY AGREEMENT AND DRAFT PREFERRED STRATEGY (CEERS) (SCRUTINY – ENVIRONMENT AND REGENERATION) –
