(4)	School attendance and persistent disengagement presentation (Martin
	Dacey.) Verbal Update.
	Martin Dacey offered the Panel a verbal update on the recent issues regarding
	school attendance. Since Covid19 it had become apparent that there were a
	significant number of children not attending school full time due to several
	factors. It was noted that only one school in Wales had 90% attendance and
	that was in Wrexham.
	Locally we were also currently experiencing a low attendance at one of our
	High Schools and this was being looked at. It was also explained that this was
	not something that could be addressed quickly as there were several
	challenging factors.

	Questions were asked by both the Chair and Councillor S. Lloyd-Selby if this
	situation was getting worse and it was noted by MD that there was no evidence
	at present of this. Although it had become significantly worse since 2019 and
	that secondary education was far worse that primary education. Many efforts

were currently being made via several channels such as social media interactions to ensure this issue did not get worse and work was continuously being put in place to assist and identify the key issues that impact attendance.

(5) Children Looked After – Breakdown (Karen Conway.)

K. Conway gave a breakdown of children looked after as of 5th September 2023. It was noted in the report that there were currently 347 children looked after and this had gradually increased. However, this number of children looked after fluctuated, influenced by the number of entrants and exits, into and from care. Of the 347 children, 161 were female 186 were male which still showed an increase in the number of male children entering care.

The ages of children looked after were as below:

0 – 5 years = **83**

6 - 10 years = 96

11 – 15 years = **109**

16 - 17 years = 59

The legal status of children looked after were:

- Care Order 239
- Interim Care Order 29
- Placement Order 17
- Section 76 **62**
- Secure Order 0
- Remand 0

There were also statistics shared that showed the legal status of children looked after, where they are placed and with regard to the cost of external placements.

(6) Any Other Business –

Future agenda items were discussed, identifying a presentation from the Youth Justice and Early Support Service in November and a presentation from Children and Young People Services and Learning and Skills regarding children with disabilities in January.
