C131 DRAFT VALE OF GLAMORGAN COUNCIL CORPORATE PLAN 2025-30 (EL/PR) (SCRUTINY – CORPORATE PERFORMANCE AND RESOURCES) –

The Leader presented the report to seek Cabinet endorsement of the draft Corporate Plan 2020-25 as the basis for consultation.

Alongside the annual budget, the Corporate Plan was one of the most important matters considered as it set out what the Council wanted to achieve for residents of the Vale of Glamorgan over the next five years and how it was planned to achieve that. The Plan was ambitious but realistic and sought to deliver the Council's vision of strong communities with a bright future.

Feedback from residents had been important in developing the Plan's five Draft Objectives, with over 4k responding to the Let's Talk survey. It was hoped that even more residents would engage with the consultation on the Corporate Plan. Tackling the causes and issues arising from poverty was a key focus throughout the Plan, as well as a statement as to how the Council would seek to work in partnership to meet the short and longer term needs of residents of the Vale of Glamorgan, working in partnership with relevant organisations.

Consultation would run from 14th October to 8th December 2024 with many opportunities for interested parties to consult on the Plan, alongside the online survey, as described in paragraph 2.32 of the report.

This was a matter for Executive decision.

Councillor Wilson referred to Paragraph 2.29 of the report and said that the Council was not looking at car parking charges within town centres and would be working with residents and stakeholders as part of the Reshaping programme to help shape the Council going forward.

Environment and Regeneration Scrutiny Committee asked that that a clear and concise summary of this document be produced for residents of the Vale of Glamorgan and for future consultations on the Annual-Self Assessment for the

Council to reach out to the public and interested groups with more specific questions on communication and accessibility around the process, which had been built into the future Corporate Plan.

Corporate Performance and Resources Scrutiny Committee discussed working with voluntary and community organisations to deliver and shape local services, which were coming forward. There were points made about specific Service Areas that were taken on board, including the challenge of recruitment and selection in care provision.

Learning and Culture Scrutiny Committee said there should be further information about Council spending and more regular use of infographics for residents. There was also discussion about safeguarding, Additional Learning Needs and school attendance.

Governance and Audit Committee referred comments regarding the 2023/24 and 2024/25 reports, which would be taken on by Officers in developing the 2024/25 report.

C138 UPDATE TO AFFORDABLE HOUSING SUPPLEMENTARY PLANNING GUIDANCE – CONSULTATION FEEDBACK, PROPOSED CHANGES AND ADOPTION (CEERS) (SCRUTINY – ENVIRONMENT AND REGENERATION) –

The Cabinet Member presented the report to advise of the results of the consultation undertaken on the updated Affordable Housing Supplementary Planning Guidance (SPG) and sought approval to apply the proposed changes and adopt the updated SPG.

The most significant change proposed following the consultation concerned the approach for prescribing transfer values in Section 106 agreements. The Welsh Government figures that transfer values were based on had not been updated since 2021 despite increases in construction costs. There was a need to ensure that the values remained up to date to ensure that private developers could continue to deliver affordable housing through s106 agreements.

The values included in the amended Supplementary Planning Guidance reflected increases to the original figures in line with Welsh Government rent inflation and a methodology for keeping the figures up to date.

A total of 10 representations were received as part of the consultation process where representers were broadly in support of the principle of increasing transfer values, however the amount of any increase differed amongst the responses and as such a balance had been proposed to achieve fair transfer values.

Delegated powers were requested to allow those figures to be updated annually following the publication of the Welsh Government social rent cap.

This was a matter for Executive decision.

- (1) To comply with the Council's Contract Standing Orders, which required contracts with a value in excess of £300k to be agreed by Cabinet.
- (2) To enable the contract documentation to be finalised with the successful supplier.
