Report Title:	Highway Maintenance Three Year Plan 2026 - 2029
Purpose of Report:	To advise Cabinet of the Highway Maintenance Three Year Resurfacing Plan and to agree the priority locations for resurfacing works, as detailed within the report and attached appendices.

<p>Executive Summary:</p> <ul style="list-style-type: none"> • The Council has a duty to maintain the highway at public expense under Section 41 of the Highways Act (1980). • The Highway Maintenance Three Year Plan 2026 to 2029 provides the foundation for delivering a well-maintained and managed highway, essential to the Vale of Glamorgan's economic, social and transport needs. • The proposed plan is attached at Appendix A to this report, with priority roads identified by the Council's Highway Engineers as requiring treatment. All roads listed within the plan for resurfacing have been assessed over 18-months in accordance with the 'Carriageway Resurfacing Prioritisation Scoring System' as detailed, at Appendix B. • Surface Dressing is a well-developed preventative treatment determined by engineering assessment only, the locations listed are detailed under 4 separate attachments of Appendix A. • Micro Asphalt preventive treatment work is no longer used and Ultithin trials continue, as a replacement alternative. • Roads scoring a total of 210 points or above on the plan will be resurfaced until the capital programme for 2026/27, is fully committed. • Those roads listed within Appendix A that do not receive works this year will be prioritised for completion the following next financial year, subject to adequate funding. Those roads listed with 	

no scores against them have been added to the plan following stakeholder referrals and will be reviewed once assessed, scored appropriately, and therefore prioritised accordingly on the list.

- Should the condition of any part of the adopted highway network require immediate attention then it is suggested that the Director of Environment and Housing be granted delegated powers in consultation with the Cabinet Member for Neighbourhood and Building Services to amend the plan, as appropriate.
- Cabinet is requested to consider the contents of the Highway Maintenance Three Year Plan 2026 – 2029 and agree the priority locations for future works.

Recommendations

1. That Cabinet considers the contents of the revised Highway Maintenance Three Year Resurfacing Plan 2026 – 2029, as attached at Appendix A – 1, 2, 3 and 4, and agrees the proposed locations for works, in principle.
2. That the Director of Environment and Housing be granted delegated authority to amend the plan, in consultation with the Cabinet Member for Neighbourhood and Building Services, if urgent highway resurfacing priorities are identified.
3. That Cabinet considers and agrees in principle the methodology that where a location is listed on the plan, only partial areas may be completed, to ensure the best use and allocation of budget.
4. That the report and supporting Appendices be referred to Place Scrutiny Committee for consideration.
5. That subject to no recommendations that would affect The Plan as proposed being received from the Scrutiny Committee, the Highway Maintenance Three Year Plan 2026 - 2029 be agreed.

Reasons for Recommendations

1. So that highway carriageway works can be scheduled as soon as practically possible.
2. To deal efficiently with changes to the plan should other highway routes deteriorate more rapidly than expected or constraints dictate that a change in priority is required to ensure the most cost-effective use of the budget allocation.
3. To ensure that the Highway Resurfacing budget (2026/27), is utilised as efficiently as possible.
4. To ensure that the relevant Scrutiny Committee can consider the details of the Highway Maintenance Three Year Plan 2026 – 2029, prior to it being formally agreed.
5. To enable the final Plan to be approved following its consideration by the Place Scrutiny Committee should no recommendations that affect the Plan as proposed, be received.

1. Background

- 1.1 Cabinet on 7th July 2023, (minute no. C72 refers), noted the contents of the current Highway Three Year Resurfacing Plan and agreed in principle locations for resurfacing works and referred the report to the Environment and Regeneration Scrutiny Committee, for consideration.

- 1.2 The Environment and Regeneration Scrutiny Committee on 19th September 2023, (minute no. 362 refers) recommended that Cabinet consider criteria used

to prioritise resurfacing areas, to properly reflect the needs of cyclists and to ensure that roads and routes used by them are suitable.

- 1.3** Cabinet on 19th October 2023, (minute no. C122 refers) noted the discussion and comments of the Environment and Regeneration Scrutiny Committee on 19th September 2023 and recognised that this had been agreed in principle within the original report presented to Cabinet on 7th July 2023 (active travel and cycling routes).

- 1.4** The local highway network within the Vale of Glamorgan is one of the Council's most valuable assets to the community for which the Council is responsible. The way it is managed and maintained has a direct impact on residents, businesses and visitors.
- 1.5** All road users depend on a reliable service from the Council to sustain the Vale of Glamorgan's economic, social and transport needs and it is therefore essential that the network is maintained to the best achievable condition.
- 1.6** The carriageway resurfacing locations that have been identified requiring treatment, represent the outcome of technical scanner survey data and or physical on-site condition assessments of the local highway network by experienced Highway Maintenance staff. These on-site assessments have taken place over the last 18 months and sites are continually assessed.
- 1.7** The locations have been assessed and recorded in a prioritised manner to ensure the most appropriate and effective use of resources to best maintain the Vale of Glamorgan's local highway network.
- 1.8** Locations in need of carriageway surfacing are attached at Appendix A (1), Surface Dressing (2) Ultrathin treatment (3) and footways (4). In the case of footways, these have been identified by the highway inspectors and via customer service requests. These sites are ranked Priority 1 to 5, with 1 being the highest priority and 5 being the lowest.
- 1.9** Delivery of the plan is subject to sufficient capital funding being provided, each financial year. All routes listed on the plan would benefit from the treatments indicated, and they are prioritised accordingly, until sufficient funding is available.
- 1.10** During 2025/26, the Council received additional funding for resurfacing works through the Local Authority Borrowing Initiative (LGBI), which provided an additional £4m over 2-years. This is part of a Welsh Governments commitment

to provide grant funding to Local Authorities to improve highway infrastructure. A breakdown of this year's capital funding, 2026/27 and later years is provided in the finance section of this report.

2. Key Issues for Consideration

- 2.1** The revised Highway Maintenance Three Year Resurfacing Plan 2026 - 2029 identifies carriageways and footways requiring treatment, to prevent further surface and structural deterioration. The plan details areas where works are proposed for the financial year 2026/27 and beyond and this supersedes the data contained in any previous plan.
- 2.2** The carriageways listed on the resurfacing plan were assessed in accordance with the Highway Maintenance Scoring Matrix, which is attached at Appendix B, to this Report.
- 2.3** The Scoring Matrix was previously revised to incorporate active travel and cycle routes, so they are considered as part of the evaluation process.
- 2.4** Locations for resurfacing that are listed at Appendix A, that are yet to show a score are locations brought to the service areas attention by stakeholders or via highway inspections. These locations remain on the list until they are scored, and for monitoring purposes.
- 2.5** Full resurfacing works remain expensive to procure, and this form of treatment generally relates to major and heavily trafficked routes. Roads that will receive resurfacing works in financial year 2026/27 will be selected from the prioritised resurfacing list.
- 2.6** Cabinet will note that the roads on the resurfacing list scoring the highest, (from top to bottom on the priority list), will generally be completed first. However, the comments column identifies any specific constraints that need to be considered to progress works safely and adequately along specific roads.
- 2.7** To ensure the best use of funding, a mix of resurfacing and preventative treatments are proposed. Whilst not a structural action, preventative treatments are essentially at significantly lower costs and a lower carbon alternative which halt the ongoing deterioration of the road surface. This helps to prevent premature failure, and more costly resurfacing works in future.
- 2.8** Additionally, it will be necessary to identify and resurface only defective elements of the highway rather than resurfacing a whole area to ensure the budget is utilised as effectively as possible.
- 2.9** In previous years, the Council has chosen to apply micro asphalt to certain areas, which is a specially developed cold applied bitumen emulsion slurry which fills small depressions and enhances the visual appearance of a carriageway sealing

up any small crazing, However, the Highway Maintenance team receive significant complaints in areas micro asphalt has been used previously.

- 2.10** In June 2025, five carefully selected, low speed residential sites were chosen to trial a new alternative material to micro asphalt and that being a thin surfacing product (Ultithin).
- 2.11** The alternative treatment has been positively received by residents and is very competitively priced in comparison to micro asphalt and on upon regular inspection, the material has performed well. This material has been used by other Local Authorities for many years.
- 2.12** Generally, our residents and road users want to see newly resurfaced roads and this alternative surfacing option, will replace the application of micro asphalt and its locations and provide an alternative cost-effective option.
- 2.13** It is anticipated that the budget available for this financial year will enable resurfacing works to be undertaken to roads scoring 210 points or above (subject to restrictions or constraints identified for individual roads on the priority list), but this will be subject to final review of actual works costs.
- 2.14** Those roads on the resurfacing list which do not receive works this year due to budget limits or other constraints will be reviewed automatically for the following year's updated Plan.

3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

- 3.1** Collaboration with others. All works will be undertaken by our appointed contractors in close liaison with the Council's technical highways officers.
- 3.2** Involving People. The service area considers concerns raised by stakeholders and customers when they have reported poor condition carriageways. Officers within the Highway Maintenance team will assess those carriageways to ensure our assets are sustainable for future generations.
- 3.3** The criteria used to assess the priorities for highways resurfacing works also considers customer complaints and claims, as well as bus routes thereby contributing and involving others by addressing community and other stakeholder priorities, to ensure that the Council can successfully continue to work towards the delivery of its identified wellbeing objectives.
- 3.4** Additionally, residents that could be detrimentally affected by works will be advised in advance so any travel restrictions can be considered during the works period, should that be necessary.

- 3.5 Looking to the long term. The proposals in this report will enable the Council to continue to work towards the Well-being Outcome, An Environmentally Responsible and Prosperous Wales and contribute towards the Council's objective of promoting regeneration, economic growth and employment by the effective use of resources and assist with maintaining good transport links for commuters and business.
- 3.6 Taking an integrated approach. The effective maintenance of the Council's local highway network contributes to the improvement of local areas aiding the safe movements of pedestrians and vehicles.

4. Climate Change and Nature Implications

- 4.1 The current externally appointed contractors are all seeking options to contribute to their own carbon reduction and all arisings from site are recycled where possible for reuse within the construction industry. In addition, each contractor produces carbon calculations for works completed and these are shared with our colleagues within the Project Zero team.
- 4.2 Well maintained roads are essential to allow and promote people to cycle safely throughout the Vale of Glamorgan. Making journeys by bicycle can assist reducing the carbon impact of travel as well as encouraging people to be more active improving their health and wellbeing. Where routes are identified on the Council's Active Travel Network Map or regularly used routes by cyclists and resurfacing is planned, Officers will ensure the surfacing is fit for both vehicles and bicycles.

5. Resources and Legal Considerations

Financial

- 5.1 There is £3.8m in the capital programme for 2026/27, for resurfacing and treatment works such as surface dressing and thin treatments (Ultithin) and also for footway improvement works. This is made up of £2m from capital funding and £1.8m from the Local Authority Borrowing Initiative (LGBI). The budget for this year and future years is illustrated in Table 1 below.

- 5.2 It is estimated that to maintain the steady state of the Council’s local highway network generally requires capital funding in excess of some £7M annually.

Employment

- 5.3 The list of specialist highway works from the Highway Maintenance three Year Resurfacing Plan 2026 – 2029 will be undertaken by external contractors appointed by competitive tender in accordance with the Council's strict Financial and Contract Procedure Rules.
- 5.4 The project management of these contracts and the priority highway works including resurfacing, thin surfacing and surface dressing will be carried out in-house by existing staff within the Council's Neighbourhood Services Highway Maintenance team.

Legal (Including Equalities)

- 5.5 As the Highway Authority the Council has a duty to meet the requirements of the following legislation.
- 5.6 The Highways Act 1980. This places a duty upon Highway Authorities to maintain highways, adopted as maintainable at public expense, and to keep them safe for public use.
- 5.7 New Roads and Street Works Act 1991: This places a duty upon Highway Authorities to co-ordinate all works in the highway for the purposes of ensuring

safety, minimising inconvenience to highway users, and protecting the highway and apparatus in it.

- 5.8** The Traffic Management Act 2004. This places a duty on Highway Authorities to ensure the expeditious movement of traffic on their road network and networks of surrounding Authorities.
- 5.9** There are no Human Rights Implications with regard to this report.
- 5.10** Any signage associated with these works will comply with the requirements contained within the Council's Welsh Language Scheme.
