## **Recommendations**

## **Reasons for Recommendations**

1. To facilitate monitoring of the audit function.
2. To enable Cabinet's oversight of the audit programme.

### **1. Background**

- 1.1 The objective of Audit Wales, as External Auditor, is to undertake audit work that enables it to fulfil the statutory responsibilities of the Auditor General. These responsibilities include:
  - Auditing financial statements
  - Assessing value for money
  - Reviewing arrangements for continuous improvement
  - Evaluating adherence to the sustainable development principle.
- 1.2 The Vale of Glamorgan Annual Audit Plan 2025 details the audit work planned by the Auditor General in the Vale of Glamorgan to meet the duties outlined above. The outputs of the Audit Plan are reported regularly to the Council to inform its self-assessment and areas for improvement.

### **2. Key Issues for Consideration**

- 2.1 **Appendix A** outlines mid-year progress on Audit Wales's work programme and timetable as aligned to the Vale of Glamorgan Annual Audit Plan 2025.
- 2.2 Key highlights in relation to the Audit Work Programme are as follows.
- 2.3 The Annual Audit summary has recently been issued and is being presented to members of this Committee alongside the mid-year work programme update.
- 2.4 In relation to financial audit work, the audit of the Council's 2024/25 Statement of Accounts has been completed and certified, with the audit certificate issued on 3 December 2025.

- 2.5** Certification of the Council's 2024/25 grant claims and returns is progressing. The Non-Domestic Rates and Teachers' Pension returns have been certified. Housing Benefit testing is nearing completion, while audit work on the Social Care Workforce Development Grant has yet to commence.
- 2.6** Audit work on the 2024/25 Joint Committee accounts hosted by the Council is underway. Audit testing for the Shared Regulatory Service is largely complete, while audit work on the Vale, Valleys and Cardiff Adoption Collaborative accounts has yet to commence.
- 2.7** The independent examination of the Council's 2024/25 Welsh Church Act Fund accounts has been completed and certified.
- 2.8** In relation to performance audit work, the review of the Council's complaints arrangements has been completed, and the final report was published in December 2025.
- 2.9** In relation to 2025/26 performance audit work, thematic and local review activity has commenced. This includes work on recruitment and retention challenges, alongside local reviews of the Council's scrutiny arrangements and Housing Adaptations. Reporting activity in respect of the recruitment and retention review is underway, with fieldwork for the local reviews scheduled during 2026.
- 2.10** A number of local government national studies are underway or planned. These include work relating to Children's Services, and follow-up work on capital planning. The national findings from the local government commissioning arrangements study is now expected to be delivered through the Good Practice Exchange function, and follow-up work in relation to Corporate Joint Committees, is currently being scoped.
- 2.11** In relation to Estyn activity, inspection and review work has continued across a number of local authorities. During the autumn term, Estyn undertook core inspections of the Local Government Education Service and Youth Service at Monmouthshire, with both reports due to be published in early 2026. In addition, Estyn, working jointly with Care Inspectorate Wales, has published an inspection report into safeguarding arrangements at Gwynedd Council.
- 2.12** As part of its 2025-26 planned work programme, Care Inspectorate Wales activity, inspection and review work has continued across a range of service areas. This includes the publication of inspection findings in respect of Regional Adoption Collaboratives, with reports published for Mid and West Wales, South East Wales and Western Bay, and reports for North Wales and the Vale, Valleys and Cardiff Adoption Service awaiting publication. Joint inspection activity has also continued in relation to Community Learning Disability Teams (CLDT) and Community Mental Health Teams (CMHT), with inspection reports published for Swansea North CMHT, Torfaen Community Learning Disability Team and Hamadryad Centre CMHT, and further reports for Powys CMHT and Carmarthenshire Community Learning Disability Team pending publication.

**2.13** Work has also progressed in relation to the introduction of ratings for care homes and domiciliary support services, alongside the development of a National Thematic Reviews Programme. Inspection activity has also continued as part of the Quarter 1, Quarter 2 and Quarter 3 2025–2026 inspection programme, and the Chief Inspector’s Annual Report 2024–25 has been published. Further work has continued in relation to Deprivation of Liberty Safeguards (DoLS) and follow-up activity linked to the joint review of mental health support for children and young people and child protection arrangements.

**2.14** Governance and Audit Committee members are asked to review and note the mid-year progress of the Vale of Glamorgan Audit Work Programme and, following their consideration, to refer the report to Cabinet for oversight.

### **3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?**

**3.1** External Regulation is an important vehicle for driving continuous improvement across our services. Progressing the improvement areas identified by our regulators not only enables us to demonstrate our commitment to continuous service improvement but also contributes to further strengthening our impact on the national well-being goals through the achievement of our well-being objectives.

**3.2** Associated action plans in response to regulatory review findings are developed with the five ways of working in mind. The focus is on developing innovative ways of working that better integrate services, whilst enabling us to work more collaboratively with our partners and citizens to involve them in improving service delivery. Our improvement actions will also focus on preventative actions that will enable us to sustain and future proof our services into the longer term.

### **4. Climate Change and Nature Implications**

**4.1** There are no implications directly arising from this report, although failure to respond to our regulatory recommendations could have a negative impact on any future external regulatory assessments and could result in a special inspection by the Auditor General for Wales if deemed that the Council is not meeting the performance requirements.

**4.2** The climate change and nature implications in respect of our regulatory recommendations will be considered as part of the development of our response (action plan) and will identify mitigating actions required to minimise any adverse consequences.

## **5. Resources and Legal Considerations**

### **Financial**

- 5.1** There is an annual audit fee aligned with the Vale of Glamorgan Annual Audit Work Programme. Any proposed changes to this will be discussed with the Section 151 Officer prior to implementation.

### **Employment**

- 5.2** There are no direct workforce related implications associated with this report.

### **Legal (Including Equalities)**

- 5.3** The statutory duties of the Auditor General are contained within the Local Government & Elections (Wales) Act 2021, the Well-being of Future Generations (Wales) Act 2015, the Public Audit (Wales) Act 2004, the Local Government Act 1999 and the Code of Audit Practice.

## Estyn

In the autumn term, Estyn conducted a core inspection to both the Youth Service and the Local Government Education Service at Monmouthshire local authority. Both reports will be published on our website towards the end of January 2026.

In addition, Estyn, alongside Care Inspectorate Wales, have published a joint inspection report into safeguarding arrangements in Gwynedd Council. The inspection found that Gwynedd Council has made safeguarding its highest priority and demonstrated a clear leadership commitment to improvement. We have seen genuine efforts to strengthen systems and processes. However, we have also identified critical areas that require attention to ensure every child is properly protected. We have made a series of recommendations focusing on measuring the impact of safeguarding work, ensuring children's voices consistently influence decisions, strengthening procedures, and evaluating training effectiveness. The safety and wellbeing of children must always come first and safeguarding is a central part of every inspection we carry out. We are committed to supporting efforts to strengthen safeguarding and ensure continuous improvement across education services in Wales. The report is available on our website [here](#). “
