### 838 COUNCIL TAX 2019/20 –

The Leader, in presenting the report, reminded Members that his sole intention was to do the best he could for all the residents of the Vale and thanked them for their earlier support of the budget.

Having agreed the revenue budget for this Council for the coming year, the Council was required to agree the Council Tax for 2019/20 and in doing so the following was taken into account: the funding required by this Council to meet the budget already agreed; the funding required by the Town and Community Councils which had all met and determined their funding requirements for the coming financial year; the funding required by the Police and Crime Commissioner for the coming financial year. The table set out in the report detailed the Council Tax for all property bandings in the Vale of Glamorgan, taking into account all of the above. The Leader moved a Motion that the recommendations contained in the report be approved.

The Deputy Leader duly seconded the Motion.

Councillor Dr. Johnson, the Leader of the Plaid Cymru Group, indicated that in line with the previous vote on the Revenue Budget proposals, he would be voting against the proposed Council Tax rise.
