Executive Summary:

To obtain Council's approval for the following elements to the Council's Constitution to be considered by Full Council:

- To include the new additions within the Constitution as outlined within paragraph 2.2 of the report
- To update the amendments relating to Scrutiny as outlined within paragraph 2.3 of the report
- To update the amendments relating to Contract Procedure Rules as outlined within paragraph 2.5 of the report
- To update the amendments relating to Officer Delegations as outlined within paragraph 2.6 of the report
- To update the amendments relating to Members' Allowance Scheme as outlined within paragraph 2.7 of the report
- To amend and update minor elements of the Constitution for factual accuracy as identified during an annual review exercise undertaken during the summer, included within Appendix A.

Recommendation

Reason for Recommendation

6. To update the Constitution to reflect amendments as outlined within the report.

1. Background

- 1.1 The Constitution remains under review on an ongoing basis. During Summer 2025, a larger review was undertaken to reflect upon the accuracy of the Constitution. Under Section 2.4 of the Constitution the Monitoring Officer / Head of Legal and Democratic Services has a duty to monitor and review the operation of the Constitution to ensure that the aims and principles contained therein are given full effect. As part of this, a key role is to make recommendations to Full Council for ways the Constitution could be amended so that current democratic processes operate effectively and efficiently being mindful of arrangements in other comparable Local Authorities.
- 1.2 Having a Constitution which is reviewed and updated regularly serves a valuable and relevant purpose by striking a fair balance between the interests of the various groups within the Council e.g. between the largest political group and opposition group, between all Councillors and between Councillors and officers.
- 1.3 Most importantly the Constitution needs to enable the Council to operate effectively. It must deliver:
 - good governance behaviours;

- effective officer / Member relationships;
- clear and effective decision-making;
- strong accountability;
- clarity and consistency.

2. Key Issues for Consideration

2.1 The Monitoring Officer / Head of Legal and Democratic Services has fully considered all aspects of the Constitution and in the interests of good governance, consistency and public participation recommends to Full Council amendments as below in relation to aspects of the Constitution.
