By requesting a variation to our current premise license for a change in hours to Friday, Saturday night and certain other days. Our business is our only sole source of income, the extra hour will be extremely beneficial for us. When we first bought our business in 2003 there were only a few food shops on Broad St, now competition is high as are overheads and bills. The lack of parking facilities during day time and evening hours makes it difficult for customers wishing to come in and hence they go elsewhere for ease of parking, the late night business that we can generate on a Friday and Saturday night compensates the loss to a point as all customers are those who are leaving the pubs and clubs.

b) The prevention of crime and disorder

A CCTV system is installed which is operated at all times 24 hours a day.

c) Public safety

We have always had a friendly relationship with the police, where CCTV footage has always been provided for incidents which have taken place on Broad St/in shop as requested. Customer areas and shop front and best part of this block of Broad St are all covered.
