Cubanas

Is a late night live and recorded music venue. Operating Friday, Saturday and Sunday, including bank holidays 10:00 - 03:30, with over 60 years of licensing experience at the premise.

It has applied for 2 temporary events notices for the following dates and times.

The representation raised by South Wales Police is based upon crime and disorder, and has been presented with a list of occurrences between June and October 23. The times are of the occurrences ranging between 15:19, 23:17, 03:21 and 03:23 In total there are 5 occurrences, two of which are linked. I to a domestic dispute.

Having reviewed the details provided for each occurrence, there appears to be little evidence that points to increase in crime and disorder.

We are happy to review each occurrence if required. However, we have not been made aware of incidents/occurrences that have taken place in other licensed premises situated near to Cubanas. As only one of the occurrences appears to have taken place inside Cubanas (domestic dispute), shouldn't we first establish if these are overspill into the area in which Cubanas is situated; rather than directly related to the premises.

Cubans normal operating hours are 10:00 – 03:30. Therefore, the time offered by South Wales police 04:00, would only provide the venue with half an hour extra.

These are short term events to provide Cubanas customers with the incentive to use its premises over the festive period, and to give their staff members extra hours to earn money in a very unsettled industry; albeit in a time when two new premises licences have recently been granted, and two more are under application for similar operating times as Cubanas. One of these (still under application for a premise licence), has been granted a Temporary events notices with a 22:30 to 4am operational time without any representation being raised?

Therefore, isn't it fair to argue that the Temporary events notices should be allowed to run, as we are unable establish any facts that point to an increase of crime and disorder, and this representation comes from a worries over a lack of police presence, rather than an inadequate application for an unrealistic operation.

It is my belief that this cannot be provided as a reason to reject the Temporary events notices! Cubanas has an already established premises licence, an operational risk assessment, with experience organised staff. Therefore, Cubanas falls far from the rejection coming from a failure to promote the licensing objectives.

I was out with friends and one of them was jumped in Cocos. I got involved and ended up on the floor. Since then, I have been having constant messages and there are posts over social media. I'm concerned that they are going to do something.

This report was made to the Police after the event. It is apparent that Police were not called to the premises at the time either by those involved or by staff. Despite the report time, it occurred approx. **02.30 on Sunday 1**st **October** and is linked to the below call.

Assault. I've got an ex-partner I haven't been with for four years. His new girlfriend was posting about me on Facebook. I messaged her to leave me alone. I've been kicked and have a lump on my head. Chest is sore, nail been ripped off.

As above, Police not called to venue by those involved or by staff. Person involved reported later in the day, after the event. Occurred approx. **02:30.**

2300287085, 26th August. Disturbance/officer requesting assistance.

At **03:21** officers were driving along Broad St when they saw an altercation between a man and a woman. It transpires that the male was trying to remove a female named from the location. was a *member of staff*, working as shot girl, who had been pushed to the ground by an unknown female.

The assailant was never identified.

2300234954, 14th July. Dispute at the door.

Male claiming assault by door staff. After being refused entry male has tried to video the SIA staff. One of these staff, described as big and bald, has allegedly twisted the males' fingers and taken the phone off him.

Incident occurred at 23:17 following the refusal of entry to an intox male.

2300210130, 25th June. Ongoing Disturbance.

At **03:23** club manager made a call to Police stating 'there is fighting'. Ongoing disturbance heard, 'he pushed us all mate' can be heard.

Update: 2 groups of males outside the premise had started shouting and shoving each other requiring security to intervene and separate them. Whilst doing this security themselves were pushed from behind by persons in the vicinity.

Once the groups were separated, they went off in separate direction. Club manager contacted Police to advise they were no longer required. The identity of those involved was never identified.

Officers spoke to his partner and awaited him to return home.

He exited a taxi and was clearly intoxicated, walking in front of an oncoming car.

He smelt of intoxicants and was slurring his words.

He also told officers he had already tried to call 101 to cancel police attendance because he didn't think it needed police to attend and it was stupid.

He told officers that the bouncer had issues with him and had done for a while.

He was asked why he didn't stop going there if he always had issues, but stated that because he had a problem with just one bouncer, that shouldn't stop him from going there.

He showed officers the recording he had taken.

This was filmed on his phone, it shows the doorman lent on the railings, are then approaches him from around 5-6 meters away, walks right up to him and raises his phone to just below the door staffs face, around 10-12 inches from his face.

He then asks for his number and the door staff puts his hand to the phone, seemingly grabbing it and turning it away from him.

This appears to be reasonable force to make space between an intoxicated male who was not allowed entry into the club due to his obvious intoxication and aggression.

TO add to this, when was asked why he wanted to go into the bar, why he had felt the need to walk right up to the door staff and that he had put the phone in the door staffs face/personal space, he became aggressive to officers.

Swearing at them and become annoyed that they disagreed with him as he stated that the phone was "nowhere near him".

As already stated had already called 101 to stop police coming out, therefore negating the assault, alongside the video showing him putting a phone in the face of door staff after causing a scene for not being allowed in.
