<p>Executive Summary:</p> <ul style="list-style-type: none"> To consider an application submitted by Kelly Alderman and Richard Phillip Gully to vary a Premises Licence under the Licensing Act 2003 in respect of Sully Sports and Social Club, South Road, Sully, Vale of Glamorgan CF64 5SP. 	

Recommendations

1. The Sub-Committee is requested to determine the application having regard to the Council's Statement of Licensing Policy, the Guidance issued by the Home Office under Section 182 of the Licensing Act 2003, the application, submissions and representations before them.

Reasons for Recommendations

1. As relevant representations were received during the consultation period and not withdrawn the Sub-Committee must determine the application in accordance with the Licensing Act 2003.

1. Background

- 1.1 The premises currently benefits from a premises licence (PRM AS0244) which authorises the following licensable activities during the house stated:

Performance of Live Music (Indoors & Outdoors), Performance of Dance (Indoors & Outdoors) and Entertainment of a similar description (Indoors & Outdoors):

Monday to Saturday	20:00 to 01:00 hours
Sunday	20:00 to 23:00 hours
Good Friday	12:00 to 22:30 hours
Christmas Day	12:00 to 14:00 hours
Christmas Day	19:30 to 22:30 hours

Late Night Refreshment (Indoors & Outdoors)

Sale of Alcohol for consumption on and off the premises

2. Key Issues for Consideration

- 2.1** On 25 March 2026 the Licensing Authority received an application to vary premises licence PRM AS0244 relating to Sully Sports & Social Club, South Road, Sully, Vale of Glamorgan CF64 5SP.

A copy of the variation application is detailed in **Appendix B**.

The application proposes to extend the start time of live music (indoors and outdoors) on Saturdays from: 20:00 to 01:00 hours to 12:00 to 01:00 hours.

Members are requested to determine the change in start time for live music (indoors and outdoors) on Saturdays; changing from 20:00 hours to 12:00 hours.

- 2.2** It should be noted that live music has been part de-regulated by the Live Music Act 2012 and therefore no authorisation is required for live music taking place at this premises (indoors or outdoors) between the hours of 08:00 to 23:00 hours, before an audience of no more than 500 people.
- 2.3** The applicant has confirmed that the variation has been applied for due to the audience size being more than 500 people.
- 2.4** The application includes an Operating schedule which sets out the steps the applicant proposed to take to promote the licensing objectives. These steps are detailed in Section 16 of the application form found in **Appendix B**.
- 2.5** In accordance with the requirements of the Licensing Act 2003, copies of the application were forwarded to the Responsible Authorities.
- 2.6** During the statutory 28-day consultation period the application has been advertised in accordance with the regulations at the premises, in a local newspaper and on the Council website.

2.7 Representations were received from ‘other persons’ (as defined by the Licensing Act 2003) in the consultation period. These representations are detailed in **Appendix C**.

2.8 No representations were received from any of the Responsible Authorities.

2.9 As relevant representations were received during the consultation period and not withdrawn the Sub-Committee must determine the application in accordance with the Licensing Act 2003.

2.10 Further updates will be provided at the start of the Sub-Committee meeting as permitted under the Licensing Act (Hearings) Regulations 2005.

3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

3.2 This report has been screened for evidence of the Five Ways of Working and how it may contribute to our Well-being Objectives.

Legal (Including Equalities)

5.4 The Licensing Act 2003 (Section 4) states that it is the duty of all Licensing Authorities to carry out their functions under the Act with a view to promoting the licensing objectives. The licensing objectives are:

- a) The Prevention of Crime and Disorder
- b) The Prevention of Public Nuisance
- c) Public Safety
- d) Protection of Children from Harm

Each objective is of equal importance and should be of paramount consideration at all times.

5.5 Section 4(3) Licensing Act 2003 states that the Licensing Authority should have regard to the Council's Statement of Licensing Policy, the Statutory guidance issued under Section 182 of the Licensing Act 2003 and the Licensing Act itself, in this case in particular to:

- a) Paragraphs 1, 2, 3, 7, 8, 9, 11, 12, 14, and 15. There is no Cumulative Impact Assessment relating to the area for this type of application.
- b) Chapters 2, 8, 9, 10 and 16 of the Statutory guidance.
- c) Sections 4, 9, 10, 11, 12, 13, 34, 35, 36, 182 and 183 of the Licensing Act 2003.

5.6 In each case the Sub-Committee may make the following determination:

- a) Grant the application as applied for.
- b) Modify the conditions of the licence, by altering, omitting or adding to them, where relevant.
- c) Reject the whole or part of the application.

ANNEX 1 - MANDATORY CONDITIONS**Supply of Alcohol**

1. No supply of alcohol may be made under the premises licence-
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence, or his personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

Irresponsible Drinks Promotions

1. The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
2. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
 - a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - i. drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - ii. drink as much alcohol as possible (whether within a time limit or otherwise);
 - b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
 - c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
 - d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
 - e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

Free Drinking Water

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

Age Verification Policy

1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
 - a) a holographic mark, or
 - b) an ultraviolet feature.

Smaller Measures

The responsible person must ensure that-

- a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
 - i. beer or cider: ½ pint;
 - ii. gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - iii. still wine in a glass: 125 ml;



ANNEXES continued ...

- b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Pricing

1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
2. For the purposes of the condition set out in paragraph 1-
 - a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - b) "permitted price" is the price found by applying the formula-

$$P = D + (D \times V)$$
 Where-
 - i. P is the permitted price,
 - ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
 - iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
 - c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
 - i. the holder of the premises licence,
 - ii. the designated premises supervisor (if any) in respect of such a licence, or
 - iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;
 - d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
 - e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
 (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.




