## **Recommendation**

1. It is recommended that the application from A2Z Taxi Vale of Glamorgan Ltd is approved.

## **Reason for Recommendation**

1. To provide Hackney Carriage proprietors in the Vale of Glamorgan with greater choice of approved meter testers.

## **1. Background**

- 1.1 The Vale of Glamorgan Council's Conditions for Hackney Carriages state:
- 1.2 The proprietor shall produce annually to the Licensing Authority a certificate issued by a meter installer approved by the Licensing Authority stating that the meter is accurate and contains only the current Vale of Glamorgan Council's Hackney Carriage tariff.
- 1.3 There are currently six companies approved to issue Hackney Carriage meter certificates for vehicles licensed by the Vale of Glamorgan Council.
- 1.4 This matter has not been delegated to officers and is therefore a matter for the Public Protection Licensing Committee to determine.

## **2. Key Issues for Consideration**

- 2.1 On 24 March, 2022 the Council received an application from A2Z Taxi Vale of Glamorgan Ltd to be approved by the Vale of Glamorgan Council to test meters supplied by Viking Electronics and to issue meter certificates for Hackney Carriages licensed by the authority. The applicant is a registered company at Companies House registration number Company number 13398072. The application is attached at Appendix A to this Report.
- 2.2 The application also gave details of a measured mile that A2Z Taxi Vale of Glamorgan Ltd intend to use to test calibrations. The proposed measured mile has been checked using two separate online mapping apps and is confirmed as correct.
- 2.3 A2Z Taxi Vale of Glamorgan Ltd has supplied copies of their Taximeter Certificate and Taximeter Tariff Certificate attached as Appendix B to this Report.
- 2.4 A2Z Taxi Vale of Glamorgan Ltd has also supplied a letter, from Viking Electronics Ltd, as company's authorisation for A2Z to be approved testing agents. The letter is attached as Appendix C to this Report.

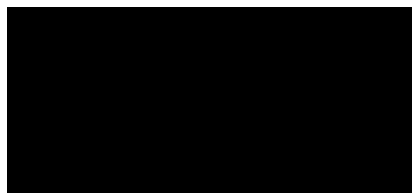
