#### **Priorities For The Year Ahead**

Lots is still required to fully achieve what I set out to do, which is why much of my work this past year is here rather than as an achievement, they are not yet delivered.

Creating safer communities on the roads and streets of Cadoc is proving to be the most difficult challenge, for women and girls facing violence, and neighbours in Coldbrook and Victoria Park along with so many others dealing with regular speeding and unsafe highways. Continuous lobbying for better street lighting, bus stops, and crossings along with delivering an active travel route for Cardiff Road and supporting the roll-out of common sense 20 mph zones. Also, much of this is a policing issue which will require constant work with our local PCSOs.

I am also going to continue focusing on appealing the Barry incinerator, as I hope we are in the endgame of the decades long process, with the people of Barry finally seeing success in defeating the plant. In the less visible realm of committees, I will do everything possible to accelerate the decarbonisation process in the council, to ensure the Council is successful in reaching net-zero by 2030.

Finally, I will further my collaboration with the youth service and I hope if you are reading this you will consider reaching out to join the Vale Youth Council, I will also keep working towards finally getting an accessible play area for Palmerston.
