#### **Constituency Activity and Achievements**

 Meetings with Departments within the Vale: Highways, Housing, Refuse, Corporate Resources, Sports and Leisure, Keep Wales Tidy, Planning briefings. Meetings have also been held with VOG staff and Councillors with the University Health Board and with Llais on a number of occasions. I attended a meeting at the Senedd regarding ADHD and Autism in women.

#### Questions asked at Council and in committee:

- Support from VOG for the government to honour the report of the Independent Ombudsman to support WASPI women
- Price increases at leisure centres in the vale

- Organisation resilience how does this look in ?
- What share of the £180 million coming to Wales for transport infrastructure will come to VOG Council and what are the plans to support the transport system with this money?
- PSCO numbers are smaller in the Vale of Glamorgan than any other Authority in South Wales the latest figures available show on average 15.25 PCSOs over a year in VOG and 58.25 in Cardiff. Are the VOG Council happy with this and do VOG feel that a question regarding funding should be asked of SWP?
- Support for carers
- Impact of proposed housing developments and lack of infrastructure to support new developments.
- Planning applications where necessary called into Planning Committee.
- Site visits requested for planning applications where necessary.
- informal site visits with VOG officers regarding planning application

I have dealt with the following issues, fly tipping, neighbour disputes, litter collection in defined areas (alley ways etc), access to refuse services, bins, housing, potholes, unsafe parking, speeding, unsafe junctions, unsafe pavements, payment of school transport.

I persuaded the VOG to collect transport payments from parents three times a year instead of once a year.

New items this year: school transport, access to special education, Welsh medium education, access to services at hospitals, control of personal information in the NHS, land that is not registered, attended an event for refuges at a high school. Took part in litter picks in the community.

On Dinas Powys Community Council I sit on the Planning Committee and the Finance and General Purposes Committee. I am a member of the Dinas Powys

Transport Group set up by Plaid Cymru, where we managed to get the no 305 bus to run up to the medical centre in Dinas Powys. I am a trustee and volunteer at Dinas Powys Library and Activity Centre. I assist two other local groups/charities - one by acting as treasurer and home visitor and the other I act as Secretary to Dinas Powys Cytun (Council of Churches).
