<b>A – B</b> Footpath No.21 Wenvoe	Commences at point A (NGR 311954 172502) and proceeds north-eastwards for approximately 120 metres to terminate on the adopted path leading from Clos Llanfair at point B (NGR 312039 172587).	120 metres	1 metre
<b>C – D</b> Footpath No.22 Wenvoe	Commences on the County Road (A4050) at Point C (NGR 312235 172261) and proceeds north-westwards across fields to terminate at the County Road (Clos Llanfair) at point D (NGR 312105 172515).	290 metres	1.4 metres

#### DESCRIPTION OF SITE OF NEW PATH OR WAY

Section of path or way as indicated on map	Position	Length	Width
<b>A – E – F – G – H</b> Footpath No.21 Wenvoe	Commences at point A (NGR 311954 172502) and proceeds south-south-eastwards for approximately 32 metres to point E (311972 172474). Following the estate road the path continues north-eastwards for approximately 88 metres to point F (NGR 312024 172544), then turns south-eastwards for approximately 65 metres to point G (NGR 312064 172495). The path continues on a surfaced path north-eastwards for approximately 46 metres to terminate on the adopted highway at its junction with Public Footpath No.22 Wenvoe at point H (NGR 312103 172517).	231 metres	1.5 metres

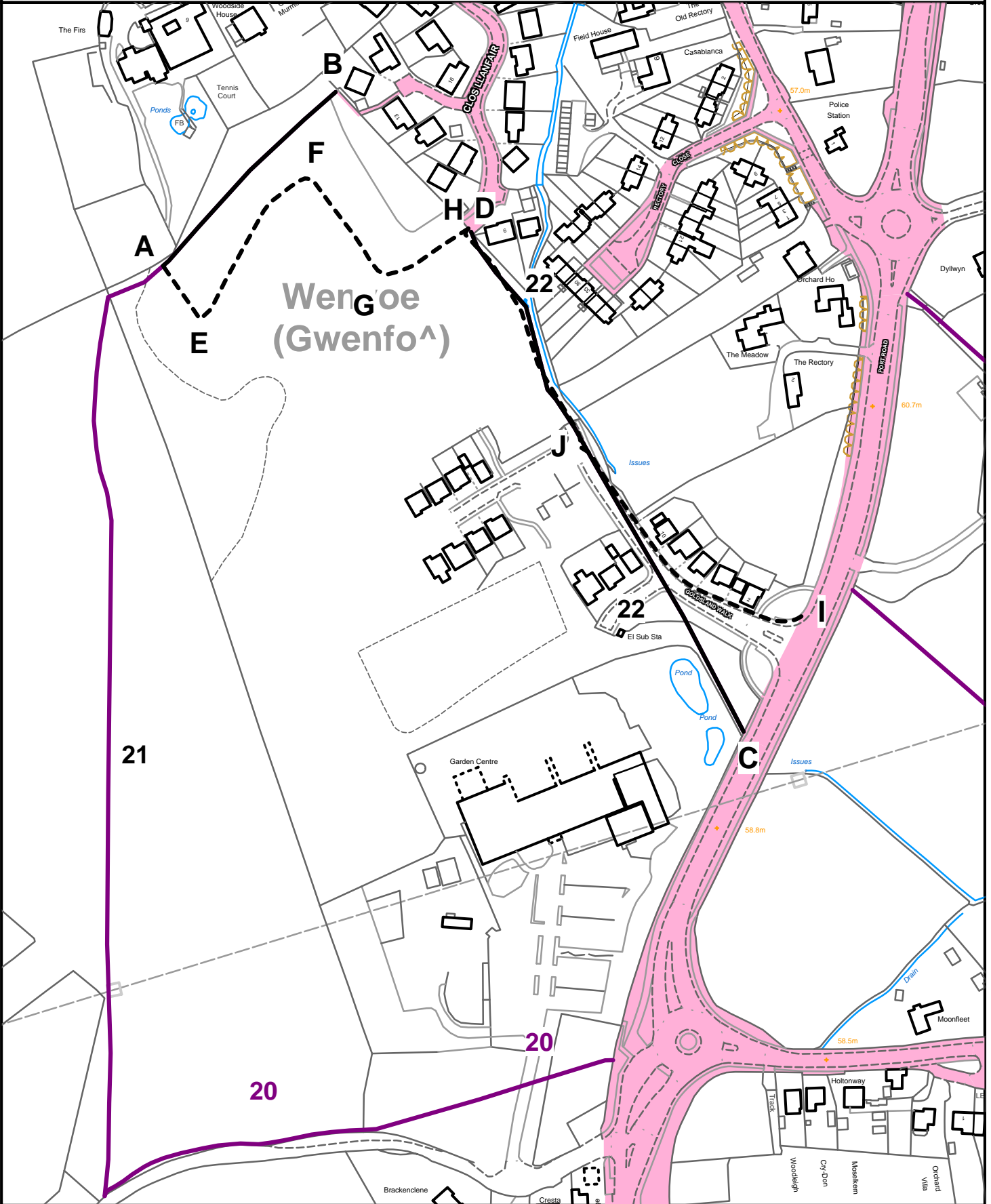
<p><b>I – J – H</b> Footpath No.22 Wenvoe</p>	<p>Commences on the adopted highway (A4050) at point K (NGR 312264 172318) and proceeds north-westwards following the pavement adjacent to the estate road for approximately 148 metres to point J (NGR 312157 172406). The path continues north-north-westwards for approximately 126 metres following a surfaced path to terminate on the adopted highway (Clos Llanfair) at point H (NGR 312103 172517).</p>	<p>274 metres</p>	<p>1.5 metres</p>
