SUBJECT: Closing of Footpaths leading into potential honey pot sites in the Vale of Glamorgan

The Department is seeking powers to close the relevant footpaths at Atlantic College, Cosmeston, Dunraven Bay, Ogmores by Sea, and Porthkerry (all as attached in the email below). These target link routes into honey pot sites and around key access points but leaves the continuous route of the wales coast path open.

This action is undertaken to minimise social interaction and gathering at specific honey pot sites and to enforce social distancing as required by recent legislation and Government advice. The decision was taken on Monday 23rd March 2020.
