**REQUEST FOR THE USE OF EMERGENCY POWERS –
CORONAVIRUS PANDEMIC**

SUBJECT: Amendment to Flexible Retirement for R which was approved by ERR

1. **Originating / Department / Service** –

Finance – Managing Director and Resources

2. **Reason for Seeking Emergency Powers** –

On 16th March 2020 the Early Retirement / Redundancy Committee considered and approved an application for flexible retirement for R. R is a Collections Officer in the Resources Directorate and requested a flexible retirement arrangement starting in May 2020 with a view to retiring by 10th November 2020 at the latest. The flexible retirement was requested to enable R to make the adjustment to retirement and to pass his knowledge on to other members of the team so that it is not lost.

Since that time, the Covid 19 situation has had a significant impact on the service, and R has approached the management team in Finance to offer to delay the start of this arrangement to July to support the service at the current time and to enable a planned hand over to take place. R has offered to extend the end of the agreement to January 2021.

This proposal would provide essential knowledge and experience to the service at a critical time and the management team in finance support this offer.
