The Department is seeking powers to allow limited access to both of the Country Parks for purposes of exercise **only** (following their closure on 23rd March) and maintain as closed all associated leisure facilities including play areas, board walks and toilets. This partial re-opening would be in accordance with recent changes to Welsh Government advice to allow unlimited exercise outdoors. The parks will be opened for exercise only and not for any leisure purposes such as picnicking or BBQs and all such areas and play areas will remain closed. The aim is that the parks will be partially re-opened on Saturday morning 16th May 2020
