The Council have been awarded grant funding of £84,008 in relation to the Small Scale Works Grant 2020-21 from Welsh Government. (Please see award letter attached). This grant requires 15% match funding (£14,824.80) which is being funded from the 20/21 Flood Risk Management budget (£100k already approved in the Capital Programme).

The grant is for:-

- Colwinston Culvert Stabilisation Works
- Ffordd-Y-Eglwys Flood Risk Management Scheme
- Picton Road Flood Risk Management Scheme
