The Council has been advised that the Welsh Government intend to award an Access Improvement Grant to support improving access to/on the Public Rights of Way network, open access land and green space in Wales.

Funding will be allocated based on the historic Rights of Way Improvement Plan (ROWIP) grant formula and The Vale of Glamorgan will therefore be eligible for an allocation of £44,075.

Funding can be used for any of the following:

- Physical improvements to existing routes (e.g. surface, furniture)
- Improvements to information and promotion (e.g. signage, way marking, leaflets, panels)
- Improvements to access to open access land and green space
- Improvements to make access to/on public rights of way network, open access land and green space easier for people who find it difficult.

It is nominally proposed to distribute this amongst the following projects:

Small Scale Infrastructure Improvement	£12,075
Capture, edit and upload promoted routes to streetview	£5,000

- Apply for / accept the funding in lieu of the external funding process.
- Include the funding in the Capital Programme 2020/21 once the grant is confirmed.

The grant will assist in meeting statutory obligations, fulfilling wellbeing objects and promoting physical outdoor activity. Improvements made under the grant will be maintained within operational budgets following conclusion of the funding.
