2. **Reason for Seeking Emergency Powers –**

The Capital Programme for 2020/21 was agreed by Council on the 26<sup>th</sup> February 2020 and included for several new schemes, particularly in schools, to be completed in 20/21 financial year. As a result of the Covid-19 pandemic, the Council experienced issues with contractors pulling off site, either because they could not adhere to social distancing requirements, they were experiencing staff shortages or they were unable to access supplies.

Emergency powers were obtained on the 31<sup>st</sup> March 2020 whereby it was agreed that all non-essential schemes should be delayed until such time as contractors were in a better position to meet the obligations of contracts entered into.

With the Construction industry gradually coming back on-line it would seem sensible to now try and progress as many schemes as possible within the 2020/21 capital programme. Supply chains, whilst still unpredictable, are starting to improve. It is therefore recommended that schemes be allowed to resume and proceed to tender/contract on a case by case basis, following full consultation and agreement with relevant chief officers within client departments. Any schemes progressing will need to adhere to Site Operating procedures which incorporate a number of technical changes as a result of the recently published Government guidance on “Working Safely during Coronavirus (COVID-19) – Construction & Other Outdoor Work”.
