CORONAVIUS PANDEMIC**

**SUBJECT:** Application for Redundancy in Respect of Employee G

2. **Reason for Seeking Emergency Powers** –

G is employed in the above division.

That a statutory redundancy payment be approved in respect of G with effect from 30th September 2020 on the basis of Scheme D of the Council's Early Retirement/Redundancy scheme.
