Barry Island Primary Boiler Renewal scheme

This scheme has a budget of £130k in the 2020/21 Capital Programme. Tenders have now been returned and when taking into account all scheme costs it is anticipated that this scheme will outturn at £100k. (-£30)

Wick and Marcross Primary Boiler Renewal scheme

This scheme has a budget of £120k in the 2020/21 Capital Programme. Tenders have now been returned and when taking into account all scheme costs it is anticipated that this scheme will outturn at £100k. (-£20)

Holton Primary Boiler Renewal scheme

This scheme has a budget of £130k in the 2020/21 Capital Programme. Tenders have been returned higher than expected due to specific difficulties set out on site within Victorian Schools, especially Holton Road Primary. For Example; Access issues require more man hours to achieve the same level of performance. Additionally, the school has had significant emergency structural repairs this year which could have had implications on the heating network. Additionally, the size and complexity of the Schools heating system, coupled with the above points could warrant an inflated cost from contractors for safety. The total cost for this scheme is anticipated to be £155k.

Emergency powers is being requested so that the Council can mobilise the contractors as soon as possible to ensure works can be completed while the school is empty.

It is requested to:-

- Vire £25k from the Barry Island Primary Boiler Renewal scheme to the Holton Primary Boiler Renewal scheme.
- Vire £5K from the Barry Island Primary Boiler Renewal scheme to the Education Contingency Budget scheme .

-Vire £20k from the Wick and Marcross Primary Boiler Renewal scheme to the Education Contingency Budget scheme.
