53 THE VALE OF GLAMORGAN LOCAL DEVELOPMENT PLAN 2011-2026: SUPPLEMENTARY PLANNING GUIDANCE ON RETAIL AND TOWN CENTRE DEVELOPMENT AND ECONOMIC DEVELOPMENT, EMPLOYMENT LAND AND PREMISES – MEMBER BRIEFING SESSION FEEDBACK (REF) –

The reference from Cabinet of 11th May, 2023 as contained within the agenda was presented by the Principal Planner.

Cabinet had previously received a report of 29th September, 2022, which outlined the need to prepare new Supplementary Planning Guidance (SPG) in accordance with the monitoring framework of the adopted Vale of Glamorgan Local Development Plan 2011- 2026 (LDP). The report sought approval to undertake a 6-week public consultation on a batch of update/new SPGs in respect of the following topics:

- Retail and Town Centre Development; and
- Economic Development, Employment Land and Premises.

In accordance with minute C80, the 6-week public consultation exercise on the draft SPGs took place between Thursday, 20th October and Thursday, 1st December, 2022 with the relevant documentation being made available at the main Council offices and on the Council's website.

Cabinet had considered a subsequent report on the Consultation feedback, Proposed Changes and Adoption on 27th February, 2023, where the results of the consultation undertaken on the draft Retail and Town Centre Development SPG and Economic Development, Employment Land and Premises SPG were considered At that meeting, it was resolved to approve the amended SPGs for use in development management decisions alongside the adopted Local Development Plan (Cabinet Minute C245).

Following the 27th February, 2023 Cabinet meeting, it was identified that the Member briefing session referenced in the 29th September, 2022 Cabinet report was not held as envisaged. In order to allow Members further opportunity to comment on the documents, a Member briefing session was held on 31st March, 2023, to which all Members were invited.

The report therefore detailed the issues raised as part of the briefing session and the response to the matters raised. Following a consideration of the issues, it was determined that no further amendments were required to the SPG documents.

In reply to a query regarding wider consultation with the retail section, the Principal Planner advised that between October and December last year, the Council did target a number of retailers within town centres. The new SPGs also went to Chambers of Trade and a range of stakeholders including the Public Service Board and Town and Community Councils. As part of that, the SPGs were available on the Council's website and advertised on social media.

Councillor A. Ernest commented that he was disappointed that some of the points raised through the consultation exercise and from the Members' briefing session were not considered further. In reply, the Principal Planner advised that amendments to the SPGs had been made following the public consultation. The Appendix to the report also outlined specifically how each point raised during the Members' briefing was taken into account.

Councillor I. Perry queried whether the SPGs would be reviewed in line with the adoption of the Council's new Local Development Plan. Councillor Perry commented that the SPGs and new LDP would also have to be amended to reflect Welsh Government policies relating to environment and climate change and needed

to have more reference to sustainable communities. In reply, the Principal Planner advised that in terms of planning applications, they had to be determined in accordance with the LDP. SPGs helped support that. It was also important to consider that aims of SPGs were not to be so prescriptive that there was not any flexibility, for example in terms long term empty units in town centres. With regards to sustainable developments, guidance would cover the need for building materials to be sustainable, but it had to be at a right level of prescription otherwise some schemes may be unviable, which also in some circumstances had to be weighed against the need for affordable housing.

Members of the Committee raised further comment regarding the importance for new developments to be more architecturally pleasing and that builders and developers would be required to work within current regulations.

In terms of reviewing the new SPGs, the Principal Planner stated that the Council would make sure that these were updated to reflect policies and emerging policies in the replacement LDP.

Subsequently, it was

RECOMMENDED – T H A T the contents of the report and the feedback made as part of the Member briefing session as detailed in Appendix 1 be noted and that no further amendments should be made to the Supplementary Planning Guidance document.

The Democratic and Scrutiny Services Officer referred to two recent site visits, the first to the Waste Transfer site in Cowbridge and the second to the Household Waste and Recycling Centre in Barry. On the back of those, a third visit was being arranged

for 14th July to the Viridor Plant in Cardiff. That would commence at 10am, and further details would be promulgated in due course.

The Committee were also asked to consider areas for further review. Councillor A. Ernest requested an update report relating to the Council's Tree Strategy. The Democratic and Scrutiny Services Officer agreed to discuss that with the Director of Place

In terms of Task and Finish Review work, the Chair suggested a topic entitled - 15 Minute Communities. That related to joined up town centres including redevelopment / regeneration encompassing economy, environment, sustainable transport, tourism, retail and amenities. It would also look at how rural communities could be supported. The Committee agreed for that topic suggestion to be passed to the Scrutiny Committee Chairs and Vice-Chairs Group for further consideration.

Having considered the contents of the report, it was

RECOMMENDED -

- (3) THAT the Committee's proposed Annual Forward Work Programme Schedule for 2023/24, attached at Appendix E to the report, be approved and uploaded to the Council's website.
- (4) T H A T a Task and Finish Review suggestion entitled "15 Minute Communities" be referred to the Scrutiny Committee Chairs and Vice-Chairs Group for further consideration to ascertain whether the suggestion is progressed.
