### "C74 RESHAPING SERVICES – DAY TIME OPPORTUNITIES FOR OLDER PEOPLE (SCH) (HEALTHY LIVING AND SOCIAL CARE SCRUTINY COMMITTEE) –

The Day Service provision for older people in the Vale of Glamorgan had been identified as one of the Council's Reshaping Services Projects and a target of £50,000 was included in the Council's revenue budget savings proposals for 2019/20.

Adult Services currently supported three day centres for older people assessed by the department as eligible for the service; all of which provided a midday meal, a range of social activities and transport to and from the centre.

- Rondel House (Barry) was operated by Adult Services, providing a 5 day per week service for up to 25 older people and people living with dementia in mid and eastern Vale;
- St. Johns (Barry Island) was operated by Carers Trust, providing a 6 day per week extended hours service for up to 14 older people with dementia in mid and eastern Vale.
- Western Vale (Gathering Place, St. Athan) was operated by Hafod, providing a 5 day per week service for up to 10 older people living and people living with dementia in the Western Vale.

In addition to the day centres, there was a range of over 35 separate community groups throughout the county that provided social opportunities for citizens covering a range of interests and activities, including lunch clubs, sports clubs, craft clubs and social clubs.

A Project Group had been set up to explore the best way to maintain a quality service while making the efficiency savings.

The project group would develop and consult upon a model of day-time opportunities for older people and people living with dementia.

Following a comprehensive consultation exercise with current service users of the day centres, staff employed in the day centres and wider stakeholders, the project group would develop a Day Opportunities Strategy to inform the future day time opportunities for older people and people living with dementia in the Vale of Glamorgan.

The Cabinet Member for Social Care and Health advised that options C, E and F on Appendix 1 of the report favoured an enhanced service at Rondel House and were recommended for further consideration.

**Executive Summary:** 

- The Day service provision for older people in the Vale of Glamorgan has been identified as one of the Council's Reshaping Services Projects and a target of £50,000 is included in the Council's revenue budget savings proposals for 2019/20.
- Adult Services currently supports three day centres for older people assessed by the department as eligible for the service; all of which provide a mid-day meal, a range of social activities and transport to and from the centre.
  - **Rondel House** (Barry) is operated by Adult Services, providing a 5 day per week service for up to 25 older people and people living with dementia in mid and eastern Vale.
  - **St. Johns** (Barry Island) is operated by Carers Trust, providing a 6 day a week extended hours service for up to 14 older people with dementia in mid and eastern Vale.
  - **Western Vale** (Gathering Place, St. Athan) is operated by Hafod, providing a 5 day a week service for up to 10 older people living and people living with dementia in the Western Vale.
- In addition to the day centres, there is a range of over 35 separate community groups throughout the county that provide social opportunities for citizens covering a range of interests and activities; including lunch clubs, sports clubs, craft clubs and social clubs.



- A Project Group has been set up to explore the best way to maintain a quality service while making the efficiency savings.
- The project group will develop and consult upon a model of day-time opportunities for older people and people living with dementia.
- Following a comprehensive consultation exercise with current service users of the day centres, staff employed in the day centres and wider stakeholders, the project group will develop a Day Opportunities Strategy to inform the future day time opportunities for older people and people living with dementia in the Vale of Glamorgan.

## Recommendations

# 1. Background

- **1.1** Adult Services remain committed to providing high quality day services for older people and those living with dementia in the Vale of Glamorgan.
- **1.2 Phase 1:** Involves the improvement of the toilet/wash room facilities at the Gathering Place to enable people who may require personal care support to access the toilet and washroom facilities. Currently, individuals with this need for personal care have to travel from the Western Vale to Barry for a day service which can meet their needs. This work is due to be completed by the end of July 2019.
- **1.3 Phase 2:** The challenge provided by the Reshaping Programme to find £50,000 savings from older people's day services has prompted a review of the current provision.
- 1.4 Over the course of the last five years, the numbers of people attending day centres in the Vale has remained fairly stable, but the complexity of the needs of the day centre attendees had increased, with more people needing 1 to 1 personal care, assistance at meal-times or to ensure that people do not become disorientated and wander out of the building. These additional needs, place additional demand on the staff and on the facilities within the building.

- 1.5 Rondel House is an attractive, flexible building that can accommodate up to 40 people with increased staffing ratios, but currently offers a service for up to 25 people for 5 days per week. It has a recently renovated fully equipped commercial kitchen and has facilities to support personal care and bathing. During 2018/19, an average 77 people (or 62%) attended each week out of a maximum total places of 125.
- **1.6** The service currently costs the department £373,067.21 p.a.
- 1.6.1 Cost per attendee (assuming full capacity) : £57.39 per day
- 1.6.2 Cost per attendee (actual attendees based on occupancy) : £93.17
- 1.7 St. Johns is leased from Barry Island Methodist Church and can accommodate no more than 14 people but is currently contracted to provide a service for up to 10 people 6 days per week. It has a fully equipped kitchen and facilities to support personal care. During 2018/19, an average of 49 (or 81%) attendances were made each week out of a maximum total of 60.
- **1.8** The service currently costs the department £134,262.32 p.a.
- 1.8.1 Cost per attendee (assuming full capacity) : £34.68
- 1.8.2 Cost per attendee (actual attendees based on occupancy) : £52.69
- **1.9** It is noted that the relative cost per attendee is significantly more for people attending Rondel House compared to attending St. Johns. This is due to the higher costs of employing staff on Vale of Glamorgan terms and conditions, higher transport costs for Rondel House and additional kitchen staff.
- **1.10** An Options Appraisal has been carried out by the Day Services Project Group which identified that the operation of an extended service at Rondel House that could cater for the current attendees at both Rondel House and St. Johns.
- **1.11** The Rondel House building was favoured over St. Johns' as it has capacity for more day centre attendees each day, it is owned by the Council, has recently been renovated, and has good access to Barry town centre for community activities.
- **1.12** The transition of the St. John's Day service to Rondel would maintain current service levels, release the £50,000 savings target and provide an opportunity to invest in the development of more preventative social opportunities in the community.
- **1.13** A feasibility study is being undertaken by the Resource Centre Manager at Rondel House and Head of Care at Carers Trust to examine the maximum number of attendees at Rondel House and the staffing structures required to provide a high quality safe and enjoyable experience for the people attending the day centre.
- **1.14 Phase 3:** The Social Services and Wellbeing (Wales) Act 2014 strengthens the duties on local authorities to provide preventive opportunities that support people's wellbeing through partnership and cooperation. The Cardiff and Vale of Glamorgan Population Needs Assessment stated that the proportion of the population over 65 years will grow from 20.1% in 2015 to 24.3% in 2025 with the

most significant increase in people over 85 years, with the number of people (65 and over) living with dementia increasing by 1462, indicating a need to develop a wider range of preventative social opportunities.

**1.15** There are currently at least 35 separate groups offering support, information and social opportunities for older people across the Vale of Glamorgan. Phase 3 of the day services reviews working with the Glamorgan Voluntary Service and the Dementia Friendly Community Steering Group to provide assistance to the groups to promote their offer, make them more sustainable and support them to become more accessible. We will also look for gaps in terms of activities offered across the Vale and direct support to facilitate local community groups to fill the gaps.

# 2. Key Issues for Consideration

- **2.1** Cabinet is asked to give permission for the project group to consult on the options for the operation and delivery of the day services for older people and people living with dementia in mid and eastern Vale.
- **2.2** The Consultation process will involve meeting with attendees of both St John's and Rondel House. Additionally each attendee and their carer, if they have one, will be written to regarding the future proposals and given the opportunity to provide written feedback. Individuals will also be offered 1:1 consultation sessions if needed. It is envisaged that the consultation will run from 5<sup>th</sup> of August to the 4<sup>th</sup> of October.
- **2.3** The project group will complete an Equalities Impact Assessment to inform the service developments taking into account any potential deleterious impacts on particular population groups.
- 2.4 The Options Appraisal attached shows the Options A to G considered by the Project Group. Options A, B, D and G are not supported; Options C, E and F favour an enhanced service at Rondel House and are recommended for further consideration.
- 2.5 The Rondel House building has recently been refurbished and offers a pleasant and functional space for over 40 people per day. Additionally, the building could be used to support local community groups in the evenings and weekends. The facility at St. Johns' Church on Barry Island does not have the space or facility for the increased numbers that a single day centre would require.
- **2.6** A feasibility study is being undertaken to identify the additional resources (including staff, meal provision, and transport) which would be required to operate the service for up to 40 people at Rondel House. The feasibility study will also include any capital improvements to the toilet/washroom/kitchen and day room facilities needed to cater for the increased numbers.
- **2.7** A move from St. Johns to Rondel House could cause some disruption to the day time support of the current attendees at both day centres. Any such move would require careful management by staff from both centres.

- **2.8** The potential employment implications for council staff will need to be explored and consulted upon prior to any change in service.
- **2.9** The exact savings opportunity from Option C will not be available until after the completion of the feasibility study but early indications suggest a saving in excess of the £50,000 target could be achieved.
- **2.10 Option C:** Change the current contract with Carers Trust to cease the day centre service at St. John's and provide a service for up to 40 people per day at Rondel House.
- **2.11** Carers Trust have consistently shown that they provide a service that is highly valued by service users, carers and social workers at a significantly reduced cost to the council.
- **2.12** The potential employment implications for staff will need to be explored and consulted upon prior to any change in service.
- 2.13 The exact savings opportunity from Option C will not be available until after the completion of the feasibility study but early indications suggest a saving in excess of the £50,000 target will be achieved. It is likely that additional funds will be released from Option C to enable investment to support the development of Phase 3.
- **2.14 Option E:** Change the current contract with Carers Trust to transfer the day centre service at St. John's to Rondel House and jointly provide a service for up to 40 people at Rondel House.
- **2.15** The provision of the service by staff from both St. Johns and Rondel will provide consistency of care to the day centre attendees which is intended to reduce the effects of the transition to Rondel House.
- **2.16** The potential employment implications for staff will need to be explored and consulted upon prior to any change in service.
- 2.17 The exact savings opportunity from Option E will not be available until after the completion of the feasibility study but early indications suggest a saving in excess of the £50,000 target will be achieved. It is unlikely that this option will produce cost savings to allow for the investment to support phase 3.
- **2.18 Option F:** End contract with Carers Trust and procure a new provider to provide a service for up to 40 people at Rondel House.
- **2.19** The service will be provided by a new provider which will cause additional disruption to the current day centre attendees, which could be mitigated by TUPE arrangements.
- 2.20 The exact savings opportunity from Option F will not available until after the completion of the feasibility study but early indications suggest a saving in excess of the £50,000 target will be achieved. It is considered less likely that this option will produce cost savings to allow for the investment in phase 3.

# 3. How do proposals evidence the Five Ways of Working and contribute to our Well-being Objectives?

- 3.1 Long Term
- 3.1.1 The council's commitment to developing day time opportunities represents a focus on the long term wellbeing of individuals using the service and also the sustainability of social care by supporting carers and reducing demand on alternative care and support at home.
- 3.2 Integration
- 3.2.1 Day services provide venues for health professionals to offer interventions with people where a more clinical setting is not appropriate.
- 3.3 Involvement
- 3.3.1 Day opportunities allows people to take more control over their lives by providing information so people are more informed to make care and support decisions.
- 3.4 Collaboration
- 3.4.1 Day services offer an opportunity for adult services to work with partners to provide a coordinated provision of daytime opportunities for people both within day centres and the wider community.
- 3.5 Prevention
- 3.5.1 Day services supports an Active and Healthy Vale by promoting healthy lifestyles, reducing loneliness and enhancing wellbeing.

# 4. Resources and Legal Considerations

#### **Financial**

- **4.1** Adult day services are required to present a £50,000 saving from reshaping day opportunities for older people and people living with Dementia in the Vale of Glamorgan.
- **4.2** The costs associated with the current arrangements are provided in the body of this report.

# **Employment**

**4.3** Any changes to the operation of day services at Rondel House may impact on staff directly employed within the day centres. Should any proposals be developed that would impact upon staff, consultation and engagement with staff and the recognised Trade Unions would be undertaken in line with the Council's well-established policies relating to the management of change.

# Legal (Including Equalities)

**4.4** There are no legal implications as a direct result of this report at this time.

- **4.5** Any proposals to change the nature of the way in which day services are provided would be accompanied with an Equalities Impact Assessment and a Privacy Impact Assessment.
- **4.6** Any proposals to change the current contractual arrangements with partner organisations would be accompanied by the same.
