The Officer advised of the following as recent updates to the work of the Committee:

- The new Police and Crime Commissioner (PCC) would be attending a forthcoming Committee meeting in order to give a presentation to Members regarding their priorities for their role and how this would impact the Vale of Glamorgan. This was provisionally scheduled for the November 2024 meeting.
- The planned Committee visit to the Vale Food Bank was now scheduled for Thursday, 17th October, 2024.

The Head of Housing and Building Services also advised the following:

- An update regarding site selection for the Gypsy and Traveller Community was due to come to Committee shortly, and hopefully before Christmas.
- The current Housing Development and Acquisition Policy would be revised to include Committee's recommendation that larger scale property acquisitions be reported to Committee directly prior to acquisition for consultation and consideration, and that ward member consultation happened for individual properties acquired to increase the Council's social housing stock. The revised Policy would be presented to Cabinet before coming to Committee for consideration at the appropriate time.

RECOMMENDED -

- (2) T H A T the two historic ongoing recommendations regarding a report identifying an appropriate housing solution for the Traveller community, and the DAARC service's engagement with support groups concerning domestic abuse, be marked as completed for the purposes of the Committee's recommendation tracking document, and alternatively that updates be provided to the Committee by the relevant Officers, as and when appropriate.
