1.0 What is this report about?

- 1.1. This report and Appendix A provide an update on progress with the wide range of activity being undertaken to ensure the Council continues to deliver against commitments in the Climate Change Challenge Plan and to take forward Project Zero. This includes the RAG (red, amber, green) rating of progress against the steps in the Climate Change Challenge Plan (Appendix A).
 - 1.2. Progress and developments from October 2025 to March 2026 are detailed including the completion of a PSB Climate Change Risk Assessment funded by the Shared Prosperity Fund, the roll out of soft plastic collections across the Vale, and planting of around 15,000 trees.
 - 1.3. This report provides updates on the Public Services Board (PSB) work to tackle the climate and nature emergencies which is a priority in the PSB Well-being Plan.
- 1.1 The report also updates on the approach to programme management, the 2025/26 performance relevant to Project Zero at Appendix B, and the 2026/27 performance measure for the year ahead at Appendix C.

3.0 What is the background to this report?

3.1. At the Council meeting on the 29th July 2019 Council resolved (minute 209 refers):

- (1) T H A T the Vale of Glamorgan Council join with Welsh Government and other Councils across the UK in declaring a global 'climate emergency' in response to the findings of the IPCC report.
- (2) T H A T the Vale of Glamorgan Council reduce its own carbon emissions to net zero before the Welsh Government target of 2030 and support the implementation of the Welsh Government's new Low Carbon Delivery Plan, to help achieve the Welsh Government's ambition for the public sector in Wales to be carbon neutral.
- (3) T H A T the Vale of Glamorgan Council make representations to the Welsh and UK Governments, as appropriate, to provide the necessary powers, resources and technical support to Local Authorities in Wales to help them successfully meet the 2030 target.
- (4) T H A T the Vale of Glamorgan Council continue to work with partners across the region to develop and implement best practice methods that can deliver carbon reductions and help limit global warming.
- (5) T H A T the Vale of Glamorgan Council work with local stakeholders including Councillors, residents, young people, businesses, and other relevant parties to develop a strategy in line with a target of net zero emissions by 2030 and explore ways to maximise local benefits of these actions in other sectors such as employment, health, agriculture, transport and the economy.

3.2. [Project Zero](#) is the Council's response to the climate emergency. At the Council meeting on the 26th of July 2021 the Council approved the Climate Change Challenge Plan (minute 296). The Plan details eighteen challenges and eighty underlying steps framed around the

need to demonstrate strong leadership, fulfil our responsibility to current and future generations and to make a difference now.

- 3.3. At the Council meeting in July 2021 a motion was also passed resolving to declare a Nature Emergency (Minute 289).
- 3.4. The Council's Corporate Plan, Vale 2030, sets out the Council's five Well-being Objectives, how they will be delivered and the key priorities. Vale 2030 includes a commitment on respecting and celebrating the environment, including reducing our carbon emissions as an organisation and encouraging and supporting others to do the same. This includes a focus on the changes needed to how we travel, the energy we use, the waste we create, and our food. Vale 2030 is supported each year by five Directorate Plans and a raft of annual performance measures. Vale 2030 sets out the continued vision for the Council's work in response to the climate and nature emergencies and is aligned to the commitments in the Challenge Plan.
- 3.5. The Challenge Plan sets out activities that will contribute not only to the Council's aim of being net zero by 2030 but the wider aim of being net zero across the Vale by 2050, improving biodiversity, and contributing to the Welsh Government 30 by 30 target and ambitions for the public sector and for Wales. In order to support our drive to net zero, a [Carbon Management Plan](#) was approved by Cabinet in 2024.
- 3.6. In response to the July 2022 Corporate Performance and Resources Scrutiny Committee recommendations, a 'RAG' rating system (Red, Amber and Green) for progress has been continued at Appendix A. The rating in this report reflects the progress from October 2025 to March 2026 only, and the ratings may fluctuate over time to reflect new opportunities and barriers in future reporting periods.

4. What issues are there to be considered?

- 4.1. This report and Appendix A provide an overall update on the wide range of activity being undertaken as part of Project Zero. Progress under each step is summarised, along with examples of activities undertaken against each challenge.
- 4.2. In addition, this report provides Performance Measurement data for 2025/26 at Appendix B. Highlights show a rise in the number of residents who say they are using public transport (64.8%), walking routes (75.8%), and cycling (18.5%). The number of electric vehicles has increased by 9 since last year, making up 11.7% of our fleet. The Council significantly increased the area of parks, open spaces and highways land managed as wildflower or naturalised areas, exceeding the annual target. Performance Measures for 2026/27 are at Appendix C.
- 4.3. Some of the key progress from October 2025 to March 2026 in delivering the Climate Change Challenge Plan is detailed below. In Q3&4 2025/26 the overall RAG rated progress is shown in table 1 below, with 69 of the 80 steps business as usual or on track.

Five steps show slower than expected progress, and there are 2 steps each for completed, no planned action, and no progress. Highlights from the period are shown in the bullets below Table 1.

Demonstrate strong leadership - Challenges 1-4

- Engagement with resident groups was undertaken to support the evidence base for the PSB Climate Change Risk Assessment. We gathered a broad cross section of experiences of extreme weather from our communities including carers, young people, housing tenants and older people.
- A number of experts and consultants have supported work related to climate and nature: the outputs include the Vale PSB Climate Change Risk Assessment; the Economy, Employment and Skills Study of the Vale of Glamorgan; and energy audits of key buildings.
- Placemaking work, developed with Town Councils and residents, is moving forward with a number of priorities identified that support nature and decarbonising transport.
- Directorate Plans for 26/27 include a range of activities to take forward commitments in the Climate Challenge Plan and Vale 2030. These are also reflected in the [Annual Statement](#) for 26/27 which includes commitments for cleaner local environments, reducing carbon emissions in our supply chains, expanding soft plastics recycling and investments in public transport and our parks.

Fulfil our responsibility to current and future generations - Challenges 5-12

- Around 15,000 trees have been planted by multiple directorates during this period including a large proportion through the Restore the Thaw Landscape project.
- Section 106 funding has delivered projects with biodiversity and environmental benefits. This includes new innovative red lighting on paths running through green spaces, reducing the negative impact of light pollution on nocturnal animals.
- Enhancements to public transport and active travel infrastructure include the upgrade of 10 bus stops and expansion of real time information at stops. In addition, a consultation on the current Active Travel Network Map has taken place.
- A draft Economic Growth Strategy is in early stages of development, with wraparound themes of wellbeing and sustainability being considered.
- In work led by Food Vale, the Vale Food Strategy was launched in this period, and the Silver Sustainable Food Places award was achieved.

- The soft plastics pilot came to an end with a full roll out of the service now in place across the Vale, along with a new textiles waste pilot in Barry. During the pilot, 72 tons of soft plastics were collected and kept out of the residual waste stream.
- The Local Area Energy Plan (LAEP) has been reviewed and refined, and the Vale has been secured as a partner county to pilot a project with NESTA (the charity National Endowment for Science, Technology and the Arts), on their Clean Heating Planning Tool.
- The Council participated in the Switch Together (formerly Solar Together) scheme, which in just over six months to December 2025 saw 109 households install 1,401 solar panels, creating 630kW of clean energy capacity and saving an estimated 89,916kg of CO₂ in the first year. The programme generated over £1 million of private investment in local homes and supported 40 Welsh installers.

Make a difference now - Challenges 13-18

- A procurement dashboard was launched in November 2025. This shows carbon and spend data by quarter raising visibility and awareness of the environmental impacts of supply chain spend.
- Phase 2 of the new build Social Housing development at Hayeswood Road, Barry, received Welsh Government Technical Approval in November 2025, which accepted the new pattern book layouts and the proposed Association for the Environment Conscious Building (AECB) CarbonLite Standard. This is a more rigorous energy standard than the typical SAP as it focuses on a higher thermal performance of the building fabric, a reduction in cold bridging, improved air tightness, and resulting in a lower need for heating.
- A new school's eco-directory has been launched and will help schools become more sustainable while reducing operational costs.
- Additional funding has been secured for decarbonisation feasibility studies - £20k from Welsh Government Energy Service for energy efficiency feasibility designs to be developed for Barry Library & Town Hall, and the Civic Offices, and £35k from Ystadau Cymru for feasibility studies in our leisure centres. Both projects will provide clearer guidance on future decarbonisation opportunities linked to the capital programme and other funding sources.
- New solar panels have been fitted at the Cosmeston Warden's office as part of a roof refurbishment. The solar panels fitted on the nursery roof of Rhyws Primary have supported a 20% reduction on grid energy use and have saved £6,000 on utility bills in their first year.
- Eight new EV vans are now operational and in use by the Highways team and waste supervisors. Travelling on average around 7,000 miles a year each, the switch from diesel to EV will significantly reduce related emissions.
- Over 2025/26, our printing volumes have reduced by 25% saving paper, ink and energy.

4.4. Performance Measures

- Appendix B details performance in 2025/26 against a range of measures. This information will also be considered as part of end of year reporting and the Annual Self-Assessment which will be presented to Cabinet on the 9th July and Joint Performance Scrutiny Committee on the 22nd July.
- Examples of 25/26 progress as captured in performance measures included increases in investment in EV vehicles for the Council's fleet. A significant number of trees have been planted, far exceeding targets, and further planting has been undertaken in our parks

including wildflowers. There is evidence of some positive change in how people travel, but this remains an area of focus. Figures are not yet available regarding carbon emissions and municipal waste.

- As part of the development of Directorate Plans for 26/27 performance measures were reviewed and there a number of additional measures to assist in monitoring progress. The measures that will be reported in 26/27 are detailed in Appendix C.

4.5. Programme Management

- The Project Zero Board continues to steer the programme and met three times in this period. The Board reviewed the new Procurement Spend and Carbon Dashboard, reviewed high emission areas in depth, discussed the impact of Artificial Intelligence (AI) on the environment, and heard from the new LAEP officer about next steps for the Local Area Energy Plan. During the period, presentations on the Council's 2024/25 carbon emissions were given to all directorates to raise awareness and prompt targeted discussion and action.
- The Welsh Local Government Association attended the Project Board to offer an opportunity to pilot their Carbon and Biodiversity in Business Cases toolkit. In 2026/27 we will be piloting the toolkit as part of the Holmview project.
- A Project Zero funding tracker was developed with the aim of gathering relevant funding opportunities from across the directorates into one place. The tracker will assist with monitoring our funding successes and opportunities.
- In addition, quarterly meetings between the Programme Manager and Senior Reporting Officers for the 18 challenges in the Challenge Plan focused on reviewing priorities for 2026/27.
- The Project Zero Programme Manager continues to engage with other Local Authorities and Public Sector bodies to learn and share good practice. This includes the WLGA Climate Officers group, the PSB Asset Management and Climate Emergency Group, and membership of the Shaping Places for Well-being programme being run by Public Health Wales and funded by the Health Foundation.
- The Project Zero Programme Manager and the communications team continue to meet regularly to roll out the dedicated communications plan.
- The Project Zero Board also manages the corporate risk on climate change and considers actions being undertaken to mitigate the risk, risk appetite and scores. At present the residual risk is considered to be high and the controls in place are maintaining that position, however it is considered that in the longer term the risk is likely to increase as the target date of being net zero by 2030 grows closer.

4.6. Resources

- Much of the work reflected in this report is resourced within existing capacity, supported by established internal budgets and annual capital funds. External annual funding pots also support work, including from the Welsh Government, for example funding for the schools building programme, for transport, and for Council housing. In addition, time bound UK Government funding pots such as the Shared Prosperity Fund (SPF) and Pride in Place funding as well as Welsh Government grant including Transforming Towns and Energy Services have enabled projects.

- Several decarbonisation schemes were delivered or commenced in the 2025/26 Capital Programme. The schemes include removing Oakfield Gas boilers and installing air source heat pumps, installing PV panels at Penarth Learning Community and Barry Waste Transfer Station. There are decarbonisation schemes in the Capital Programme totalling £2.771M from 2025/26 to 2030/31 and this budget has been allocated across a number of schemes for installation of LED lighting, PV Panels, interface upgrades and air source heat pumps

4.7. The Public Services Board

- The Vale of Glamorgan Council and Natural Resources Wales (NRW) co-chair the Public Services Board (PSB) Asset Management and Climate Emergency Group which meets quarterly and reports to the PSB.
- Consultants JBA Associates completed a Vale PSB Climate Change Risk Assessment (CCRA), funded by Shared Prosperity Funding. Using information gathered from partners on the impacts of climate on services to date, plus experiences of Vale communities, 44 recognised climate risks were assessed through an intensive, multi-stage process involving a range of stakeholders. The CCRA was reported to and approved by the PSB in April 2026, and the completed CCRA provides a shared evidence base to inform coordinated adaptation across the Vale.
- Following completion of the CCRA, partners are now working together to plan the next steps and consider the priority areas identified. The risk assessment will be incorporated into the PSB's Well-being Assessment to be published in 2027 and the Well-being Plan which will be published in 2028 and will be used by partners as part of their ongoing risk management and climate change activity.
- In addition to undertaking the CCRA during this period the group also shared learning from the 2024/25 Net Zero Carbon reporting with a particular focus on buildings decarbonisation.

5. How has evidence been used to inform the report, including the views of others?

- 5.1. This report provides details of a wide range of activity being undertaken across the Council with contributions to the report from officers across all services.
- 5.2. Appendix B details the end of year position for Project Zero performance measures and these will also be reported as part of the Council's end of year performance and Annual Self-Assessment.

6. What are the next steps if the recommendations are approved?

- 6.1. The comments and recommendations of this committee will be considered by Cabinet together with the report.
- 6.2. Any recommendations and comments will be considered by the Project Zero Board and relevant officers and responded to. Responses will be detailed in the next progress report.

7. How does this report support Vale 2030 and Reshaping?

- 7.1. Responding to the climate and nature emergencies are a priority in Vale 2030. Project Zero is the Council's response to the climate emergency and brings together work from across the Council in a co-ordinated response. Commitments in the Climate Change Challenge Plan are designed to enable the Council to meet its ambition to be net zero by 2030 and include actions that will change how we work, enable others to make changes and raise awareness about the need for urgent action.
- 7.2. This report includes details of progress spanning across the 18 challenges and 80 steps in the Climate Change Challenge Plan at Appendix A. This includes progress towards our 2030 net zero goal through decarbonising our estate including schools, our fleet, waste and supply chain. Our wider work supporting county-wide decarbonisation by 2050 and tackling the nature emergency is also reflected in Appendix A.
- 7.3. Strengthening Communities is one of the five themes in the Reshaping programme and climate and nature are key elements of our approach to transformation.

8. How does this demonstrate the Five Ways of Working?

- 8.1. The Well-being of Future Generations (Wales) Act 2015 is about sustainable development. The Act sets out a 'sustainable development principle' which specifies that the public bodies listed in the Act must act in a manner which seeks to ensure the needs of the present are met without compromising the ability of future generations to meet their own needs. In meeting their sustainability duty, each body must set objectives that highlight the work the body will undertake to contribute to meeting the seven Well-being Goals for Wales.
- 8.2. The activities set out in this report will contribute to the national well-being goals and help ensure we have a resilient Wales. The five ways of working are embedded throughout Project Zero as we work collaboratively through the PSB and with other partners. It is recognised that this is a long-term programme of work, but that action needs to be taken now and that prevention will be a critical element to this work. Involvement of the community in order for them to shape our activities and to understand the need for change is fundamental to us making a difference through our activities and we are integrating work on this agenda across the Council ensuring this is seen as the responsibility of all Directorates and staff.

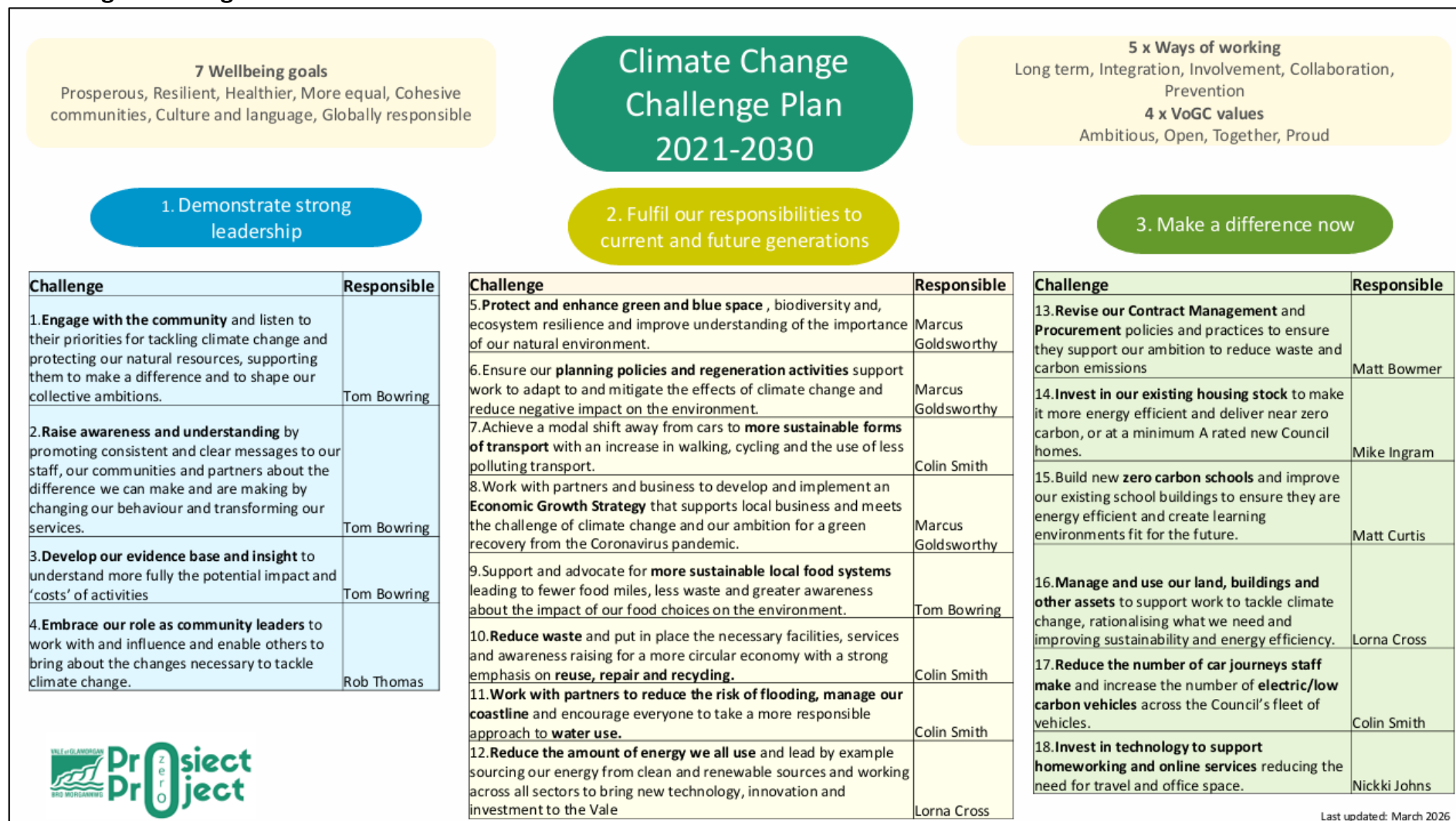

Area 1: Demonstrate strong leadership. Challenge 1-4

We will demonstrate strong leadership as we meet the challenge to effectively engage with the community and our partners about how we can work together. We will raise awareness about the issues and the work we are undertaking and develop a better understanding about where we can have the biggest impact and how we can influence others to work with us and be part of an ambitious programme of change

Project Zero: Challenge 1

Engage with the community and listen to their priorities for tackling climate change and protecting our natural resources, supporting them to make a difference and to shape our collective ambitions.

Highlights

The steps in Challenge One are now embedded into ways of working. The Council's Participation Strategy has been refreshed, and engagement to support Project Zero is embedded. During this period engagement with resident groups was undertaken to support the evidence base for the **PSB Climate Change Risk Assessment**. We gathered a broad cross section of experiences of extreme weather from our communities including carers, young people, housing tenants and older people. The Let's Talk survey results have shown that there is an increased awareness of what the Council are doing to address the climate emergency.



We continued to support and promote community participation in environmental and sustainability initiatives across the Vale. We highlighted opportunities for residents to get involved in local projects, celebrated volunteer contributions, and showcased examples of community-led action. As part of our '**Unsung Heroes - Spotlighting Volunteers in the Vale**' campaign, we caught up with the much-loved 'Tree Lady' of Rhoose. What started as one person wanting to improve Rhoose's tree canopy has grown into something truly incredible. Justine and the Replant Rhoose community have brought together over 400 volunteers to plant 8,500 bulbs, care for 250 trees, and plant 400 woodland saplings, all in just 5½ years. Countless hours, one shared passion, and a lasting impact on their community.

We also highlighted the success of the resident-led development of **Longmeadow Court in Cowbridge**, where a winter warm hub has evolved into a year-round community space featuring food growing areas, wildlife habitats and opportunities for volunteering, learning and social connection with 10,115 views on Facebook.

Highlights

Monthly Project Zero communications meetings ensure that opportunities to raise awareness are maximised, and this is now business as usual.

We delivered coordinated communications to raise awareness of sustainability initiatives, environmental campaigns and services available to residents and staff. This included signposting people to schemes that support sustainable choices, as well as promoting national campaigns that encourage positive environmental behaviours.



We promoted the **Solar Together group-buying scheme for solar panels**, with over 50 link clicks to apply, we raised awareness of the rollout of the **new soft plastic recycling service** and highlighted **sustainable travel improvements** such as new bat-friendly lighting along active travel routes and safer pedestrian crossings.

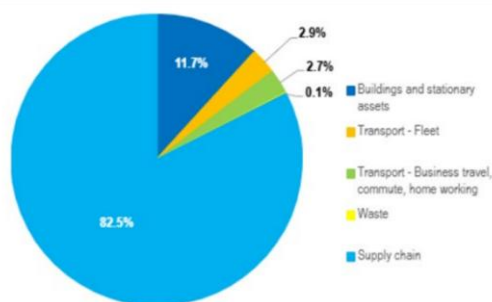
We also supported national and international campaigns including **Fix It February** which reached 58 link clicks to the 'find your nearest repair cafe' webpage, **Food Waste Action Week**, **Unison's Year of Green**, and **Earth Hour**. These communications were complemented by regular features showcasing community-led environmental projects and volunteering activity from across the Vale.

Highlights

During this period a number of **experts and consultants have supported work related to climate and nature**, including Jeremy Benn Associates who led the development of the Vale PSB Climate Change Risk Assessment, consultants Wavehill who worked with us to deliver the Economy, Employment and Skills Study of the Vale of Glamorgan (see Challenge 8 for more detail), and RSPB Cymru Nature Prescription booklet, codeveloped with Vale stakeholders, which supports people to connect better with nature to support and improve well-being. In addition, energy audits were undertaken by experts on Barry Library and Town Hall, plus the Civic Centre, the findings of which will support future decarbonisation priorities.

We continue to **promote the Project Zero suite through the Corporate Induction**. To date we have had 131 staff members take some part in the **Project Zero Learning suite**. A further 191 staff members have taken part in some of the **Biodiversity Awareness e-learning suite**. External Biodiversity training has been sourced by the Vale Local Nature Partnership, and 108 staff members attended these events. The Council's new Learning Management System (LMS) is bedding in and the current priority is ensuring that all learning is transferred accurately. Project Zero learning will remain unchanged through Q1

with the plan in Q2 to review and identify different ways to raise the profile of Project Zero and the work being done. **External training opportunities** are regularly shared, including through Project Zero Teams, with Big Fresh staff undertaking Deforestation Free training from the Size of Wales, and a number of staff taking part in the Level 3 Carbon and Energy Management Course.

The [Carbon Management Plan Year 1 update](#) was presented to Cabinet in January 2026, and presentations on the 2024/25 Net Zero Carbon (NZC) data continued to colleagues across the council during Q3 and Q4. Presentations were held by Welsh Government Energy Service WGES during Q4 on the anticipated methodology changes for reporting 2025/26. The new methodology is anticipated to be released early May 2026. Alongside our annual NZC reporting, a Carbon Data PowerBi is being developed to improve the visibility of our carbon data and help compatibility year on year.

Highlights

Our work to influence and enable is embedded across numerous work streams within Project Zero, and within the 2026/27 Directorate Plans.

Through the **Placemaking** process, Town Councils, local community groups and community members have been heavily involved in shaping plans, and setting out a vision for Barry, Penarth, Llantwit Major and Cowbridge. Numerous priorities linked to nature and the environment have been identified through Placemaking including upgrades to support active travel and public transport such as bus shelter improvements, new active travel crossings, improved streetlighting, and dropped kerbs. Other enhancements include tree planting, and replacement of standard street bins with new suites of public recycling bins to encourage behaviour change. Together, these enhancements create people-focused streets that encourage walking, cycling and social activity, reinforcing our placemaking ambitions and accelerating the Vale's transition to a low-carbon, connected future



During this period the PSB Asset Management and Climate Emergency Subgroup, which includes a representative from One Voice Wales, and from GVS representing the voluntary sector, has been working on the development of the **Vale PSB Climate Change Risk Assessment (CCRA)**. There is more detail in section 4.7 of the report. The next period will focus on each PSB organisation raising awareness of the CCRA within their organisations, and there are plans to come together in a workshop to explore collective next steps.

Work at **Cardiff Capital Region level and with CCR Energy** is explored in Challenge 8 and Challenge 12 in relation to the Local Area Energy Plan (LAEP). Work with business has continued with the relaunch of the LAEP and progress is detailed in the relevant section of this report. In addition, work has continued through the Local Nature Partnership, schools and with different groups for example the Vale 50+ Strategy Forum and through Restore the Thaw.

Finally, the VoGC will continue to champion the important role of nature and climate through a range of meetings and networks including with Welsh Government as new policies and plans are developed.

Area 2: Fulfil our responsibility to current and future generations. Challenge 5-12

In meeting these challenges, we will encourage behaviour change and adapt the necessary infrastructure to meet the current and future challenges of climate change. The focus for this section is on transport, food, nature, energy, waste, water use and flooding. In meeting the challenges, we will support a green economy and the importance of balancing economic growth with the need to minimise negative impact on the environment and our natural resources. We will take forward work to improve the green infrastructure in the Vale and to promote sustainable food systems.

Project Zero: Challenge 5

Protect and enhance **green and blue space, biodiversity, and ecosystem resilience** and improve understanding of the importance of our natural environment.

Highlights



Over the period, a **consultation on the Green Infrastructure Strategy** was undertaken alongside the Replacement Local Development Plan (RLDP). The new **Biodiversity and Ecological Resilience Plan for 2026 – 2029** has been approved by SLT and will be considered by Cabinet in July. A draft proposed **allotment agreement** has been completed and will be consulted on.

Tree planting is continuing at pace across teams. In the period, the Countryside team planted almost 15,000 trees across the Vale. The Restore the Thaw project planted almost 14,000 working with 25 landowners along the Thaw Catchment, including new hedgerows on local farms. This will boost biodiversity by providing food, shelter, and corridors for wildlife; improve soil health and water quality by reducing erosion and filtering pollutants; combat climate change through carbon sequestration; and provide advantages to local farms like livestock shelter, pest control, and extended growing seasons. In addition, the Local Nature Partnership planted over 350 trees working with seven

landowners / groups, and in Porthkerry Country Park almost 500 trees were planted across the site, with children from Ysgol Y Deri and Romilly Park schools planting out trees that they had grown from seed.

At the **Everyone's Garden project** on Margaret Avenue, Barry, a polytunnel for food growing was installed in November 2025, funded by the National Garden's Scheme. Community groups have transformed the site into a community garden for local tenants, residents, community groups and school children.

In addition, work has progressed on the creation of a **new beaver enclosure at Amelia Trust Farm**, providing training for the local community on monitoring beavers – ready for the expected release of a new beaver family in 2026/27.

Project Zero: Challenge 6

Ensure our **planning policies and regeneration activities** support work to adapt to and mitigate the effects of climate change and reduce negative impact on the environment.

Highlights

The majority of steps are on track during this period and are directly related to the development of the **Deposit Replacement Local Development Plan (RLDP)**. The RLDP was subject to public consultation between January and March 2026. It includes policies on requiring new buildings to be net zero carbon in operation, on 'presumption against demolition', on renewable energy, active travel and allocating land for active travel improvements. It sets out parameters in relation to development and flood risk and has a strategic policy on Climate Change mitigation and adaptation. Work on Supplementary Planning Guidance (SPGs) will follow in 2027/28 and may consider Sustainable Drainage Systems.

A new **green infrastructure statement and biodiversity enhancement proforma** has been developed for homeowners seeking planning for minor domestic work giving them a range of options for biodiversity enhancement to offset the impact of new works.

Thanks to **Section 106 funding**, a number of measures to support sustainable transport and biodiversity have been undertaken. Some are shared in Challenge 7, with the addition of **new wildlife-friendly red street lighting** installed at

Cross Inn Lane, Cowbridge and Cogan Pill. The lighting was designed in consultation with the Council's ecologist and operates via passive infrared sensors given the proximity to nearby trees and countryside. New benches were also installed at Wenvoe Recreation ground, South Road Sully, St.Nicholas and St. John's View, St. Athan. Wenvoe subway lighting installation is delayed due to contractor staffing issues, but due to be carried out in Q1 of 2026/27. Tree planting has taken place at Sully Linear Park with bulb planting, bee post installation, bat boxes and a nature day event planned for Q1 and 2.



Project Zero: Challenge 7

Achieve a modal shift away from cars to **more sustainable forms of transport** with an increase in walking, cycling, and the use of less polluting transport.

Highlights

All actions are on track or embedded a business as usual, including **41 pairs of EV charges now installed in 33 sites**, working in partnership with the Cardiff Capital Region and Connected Kerb. Other Investment has focused on improving accessibility and customer experience across the public transport network, including **the upgrade of 10 bus stops, and the expansion of real-time information at bus stops**. Multiple funding streams have helped deliver joined-up transport and **active travel outcomes** including: safer crossing points for school pupils on Coldbrook Road East and Ham Lane East, the extension of Barry Bike Club, Brompton Bike lockers at Cogan, and green roof cycle shelters at Cosmeston Country Park and at CF61 Llantwit Major (GVS).



Other activity includes the successful outcome of the planning application for the **Sully to Cosmeston active travel route**, consultation on the current **Active Travel Network Map** and completion of the design for the **footpath across the Police Fields in Cowbridge** – public consultation had 78% positive support for future construction.

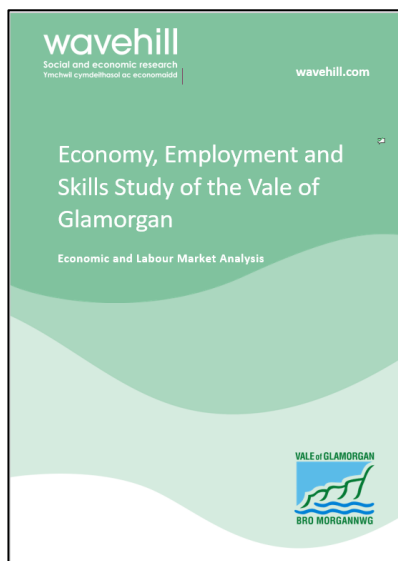
Positive feedback has been received from **Sully Primary and All Saints Church in Wales Primary on the previous award of FROG bikes and new bike sheds**, outcomes including: high success rate of children learning to ride by the end of their Nursery time; integration of bikes into outdoor play in reception; years 1 and 2 implementing Walk Wheel Cycle Trust's "Teach a child to ride a bike without stabilisers in nine steps" method, with each child using the bikes at least once weekly; year 3 timetabled bike sessions; and year 6 children using the bikes for their cycling proficiency lessons.

Project Zero: Challenge 8

Work with partners and business to develop and implement an **Economic Growth Strategy** that supports local business and meets the challenge of climate change and our ambition for a green recovery from the Coronavirus pandemic.

Highlights



All steps against Challenge 8 are on track or embedded as business as usual during this period.

An Economy, Employment & Skills Study was completed in the period and a Skills and Economy Board is being set up, with the first meeting planned in July. Findings from the study show that there is a growing need to embed sustainability and green skills across all roles in the hospitality, retail and tourism sector. For the health, social care and early years sector, embedding sustainability, climate resilience, and nature based practice into curriculum design and staff upskilling is becoming increasingly important. For Construction & built environment jobs, Current skills needs centre on embedding green and digital competencies within traditional roles, rather than creating standalone “green jobs”.

The findings of the study have supported the scoping of a **draft Economic Growth Strategy**. A framework has been developed for the strategy which will now be tested internally. With a focus on three draft key priorities – growth, skills and innovation – two wraparound themes of wellbeing and sustainability will be considered. The team are currently consulting on how the Strategy will be developed with industry, from the baseline consultations already complete, to refine and agree a fit for purpose, high level strategy that meets the needs of the Vale of Glamorgan as a county and the Council’s priorities. The project is now in the delivery phase and poised to make swift progress.

An **Apprenticeship & Careers Fair** was delivered successfully in March with over 50 employers & education, training and support organisations attended and over 400 attendees, including Dwr Cymru and Morgan Sindall Construction. In addition, relationships with CCR Energy, with Cardiff and Vale College, and with local businesses are developing to complement Local Area Energy Plan priorities (see challenge 12).

Support and advocate for more **sustainable local food systems** leading to fewer food miles, less waste and greater awareness about the impact of our food choices on the environment.

Highlights



The **Vale Food Strategy 2025–2030** was launched in October 2025, setting a clear strategic direction for improving access to healthy, local food while supporting environmental sustainability and local economic growth. Led by Food Vale, the Vale achieved **Silver Sustainable Food Places status**, reflecting strong partnership working and the impact of coordinated local action.

During this period, a range of practical initiatives have been delivered to support both producers and communities. Food Vale awarded over £20,000 through the **Sustainable and Resilient Growers (Capital) Grants 2026**, supporting 12 local horticultural businesses to invest in improvements that enhance productivity,

build resilience, and encourage more sustainable, agroecological growing practices. Alongside this, Food Vale secured **£24,400 in National Lottery funding** to further develop community growing, building on earlier mapping work and enabling more residents to participate in local food production.

Engagement with schools has been a major focus, with the launch of a **Food & Nature Schools pilot programme** in five schools. This has involved local growers delivering hands-on learning experiences to pupils, helping to build awareness of food, nature, and sustainability. Additional activity, including sessions delivered through Celtic Roots Farm as part of the Welsh Veg in Schools programme, has complemented this work. Looking ahead, a six-month programme will see more local producers engaging directly with schools, supported by a shared calendar of activities and resources being developed for rollout from September 2026, creating a lasting resource for our schools.

Big Fresh continue driving more sustainable practice: Fferm Tri Brawd near Cowbridge and Goldsland Farm in Wenvoe provide produce for 10 schools through the **Welsh Veg in Schools programme**, and all palm oil from unsustainable sources has been eradicated. Wars in Iran and Ukraine are impacting fuel costs which is pushing up food costs and this is creating challenges for growers and producers.

Reduce waste and put in place the necessary facilities, services and awareness raising for a more circular economy with a strong emphasis on reuse, repair and recycling.

Highlights

In this period the soft plastics pilot came to an end, with **full roll out of the soft plastics service across the Vale** beginning in April 2026. The Vale is the first Local Authority in Wales to roll this service out completely. During the trial period, residents collectively recycled more than 72.5 tonnes of soft plastics, including items such as carrier bags, wrapping and packaging that would otherwise have gone into the residual waste stream. Extending the collection range, a **textiles waste collection service** began in November 2025, with Barry as the pilot area.

We have significantly **expanded our reach into schools**, with 52 now signed up to our waste services. Previously many were using private commercial waste providers. We have a clear and structured onboarding programme in place through to January 2027. This growth has been driven by proactive engagement with schools, a streamlined onboarding process, and strong support arrangements to ensure each new schools integrate smoothly. Schools joining between now and January 2027 are being phased in to allow for effective training, relationship-building, and operational stability, ensuring consistent service quality as the programme scales.

All of our collected recycling is sent to properly **permitted materials recovery facilities within the UK**, where it is sorted and processed so that valuable materials can be reused and turned into new products. Green waste, food waste, and residual (non-recyclable) waste are managed locally in Cardiff, helping to reduce transport distances and support efficient, sustainable waste treatment. This local and national approach ensures waste is handled responsibly, in line with environmental standards, while maximising recycling and recovery wherever possible.

There is no progress against PZC10.6 as there are limited land options. There are ongoing discussions with WG on alternative possibilities.



Project Zero: Challenge 11

Work with Partners to **reduce the risk of flooding**, manage our coastline and encourage everyone to take a more responsible approach to water use.

Highlights

Progress in developing a **Flood Risk Management Plan** is slower than expected in this period due to staffing issues. Other activities are business as usual, with SuDS an integrated part of the planning process.

We continue to **promote water efficiency measures** in our work and buildings through regular monitoring / early intervention. Fortnightly water leak reports are produced using water leak data which are sent out to school and non-school sites. We encourage sites to pro-actively check for leaks and report issues, supported by clear guidance and steps. We review water usage through billing to highlight unusual consumption patterns and follow up when required. Ongoing communication with sites during this period has strengthened relationships and reinforced awareness to ensure issues are acted on promptly to reduce unnecessary water loss.

Housing schemes continue to deliver water efficiency measures. Developments at Clos Holm View Phase 2 and Cwrt y Chwarel incorporate SAB features, ensuring that drainage proposals for all new developments of more than 1 house or where the construction area is 100m² are designed and built in accordance with the national standards for sustainable drainage published by Welsh Ministers. Features in our schemes include rain gardens and attenuation basins which slow down and control the flow of stormwater to reduce flooding. Clos Holm View Phase 2 also incorporates rainwater harvesting systems on a number of dwellings.

Works commenced in November on the **new flood alleviation scheme at St Richard Gwyn school** in Barry. The scheme involves a 4m wide x 2+m deep trench around the perimeter of the site that manages on site surface water and also allows for surface water to be captured from Argae Lane, reducing the possibility of the road flooding and becoming impassable.

Project Zero: Challenge 12

Reduce the amount of **energy** we all use and lead by example sourcing our energy from clean and renewable sources and working across all sectors to bring new technology, innovation and investment to the Vale.

Highlights



With the new LAEP officer in role, activities in this period include **reviewing and refining the LAEP priorities**, launching a dedicated [LAEP webpage](#) and building a communications presence, building relationships with key players such as Cardiff Capital Region, NGED (National Grid Energy Generation), NESO (National Energy System Operator) and Wales and West Utilities, along with building community networks.

Along with scoping a number of funding opportunities, the Vale has been secured as a partner County to **pilot a project with NESTA** (the charity National Endowment for Science, Technology and the Arts), on their Clean Heating Planning Tool. Originally piloted in Plymouth, the tool will support local areas in identifying which type of low-carbon heating is most suitable for groups of properties at neighbourhood level, and which may need help to deliver change for households.

In support of community decarbonisation, **four Vale sports sites have been awarded Sport's Wales Energy Saving Grants**. Collectively Penarth Bowling Club, Windsor Lawn Tennis Club in Penarth, Penarth Athletic Club and Glamorgan Golf Club have been awarded almost £84,000 for works by Sports Wales.

The Vale of Glamorgan Council participated in the **Switch Together** (formerly Solar Together) scheme, which in just over six months to December 2025 saw 109 households install 1,401 solar panels, creating 630kW of clean energy capacity and saving an estimated 89,916kg of CO₂ in the first year. The programme generated over £1 million of private investment in local homes and supported 40 Welsh installers. Following this success, a second tranche launched in January 2026, building on strong uptake.

Separately, the **ECO4 Flex scheme** concluded in March 2026 with 142 successful applications for fully funded energy efficiency improvements, with residents continuing to access guidance via council webpages.

Project Zero: Challenge 13

Revise our **Contract Management** and **Procurement** policies and practices to ensure they support our ambition to reduce waste and carbon emissions.

Highlights

The procurement Staffnet page has been refreshed, and the focus on buying responsibly has been strengthened. The **procurement dashboard**, launched in November 2025, shows carbon and spend data by quarter raising visibility and awareness of the environmental impacts of supply chain spend

Our procurement partners Ardal continue to work at regional level and with the Welsh Government to drive more sustainable procurement, including piloting a new reporting tool to collect more accurate carbon data from suppliers which will in turn support better annual net zero carbon reporting to Welsh Government. During the next reporting period **Ardal will be contacting the top 10 suppliers** for each of the four Ardal councils and will provide those suppliers with the new WGES NZC supply chain reporting spreadsheet for 2025/26 to complete.

Step 1: Think before you buy

Before you start any procurement, whether you are buying office furniture or building a new school, it is important that you have read **An Introduction to Buying Responsibly** and that you consider the following:

- CHALLENGE WHAT YOU ARE BUYING**
Before starting any procurement process, you must challenge what you are buying and whether you even need to buy it.
- USE IN-HOUSE OR EXISTING CONTRACT**
You need to check the Supply Directory to see if there is any in-house provision or an existing contractual arrangement that can meet your requirements.
- CONSIDER THE WELLBEING IMPACT**
You need to consider the environmental, social, economic, and cultural impact of what you buy and how it is delivered.

During this period, Ardal has also worked with **WRAP to develop guidance on sustainable procurement** across several supply chain categories, ensuring we embed decarbonisation, circular economy and sustainable requirements into tenders where possible. Once finalised, the guidance will be shared with procurement colleagues and embedded into a co-pilot agent which, once tested, will be rolled out making it easier for service areas and procurement colleagues to embed sustainable requirements into tenders.

Ardal have also **reviewed their Carbon Reduction Plan (CRP) thresholds** and have worked with other SEW authorities to develop minimum standards for CRPs. The region is working towards adopting the following thresholds, which Ardal has already implemented: for tenders over £5m, a CRP is required at tender submission; and for tenders between £2m and £5m, suppliers must confirm that they will provide a CRP within six months of contract commencement.

Ardal will be reviewing supplier Terms and Conditions to ensure that commitment from suppliers towards social (community benefits) and environmental issues is included. **Community Well-Being (CWB) benefits** are included in contracts over the value of £250k, and support local community projects through school engagement, employment pathways, community support and environmental initiatives. Ardal's CWB Benefits team helps contractors fulfil and record their community wellbeing benefit commitments via the Thrive Social Value database, with almost £2000 of CWB delivered in the Vale during this period.

Project Zero: Challenge 14

Invest in our existing housing stock to make it more energy efficient and deliver near zero carbon, or at a minimum A rated new Council homes.

Highlights

Phase 2 of the new build Social Housing development at Hayeswood Road, Barry, received Welsh Government Technical Approval in November 2025, which accepted the new pattern book layouts and the proposed **Association for the Environment Conscious Building (AECB) CarbonLite Standard**. This is a more rigorous energy standard than the typical SAP as it focuses on a higher thermal performance of the building fabric, a reduction in cold bridging, improved air tightness, resulting in a lower need for heating. A future scheme at Myrtle Close, Penarth (32 units) also proposes to achieve the AECB Carbonlite Standard.



New housing schemes at Clos Holm View Phase 2 (31 units), Cwrt y Chwarel (20 units) and Olive Lodge (10 units) were completed, all **achieving an EPC 'A' and SAP 92+ rating**. Heating and hot water generation does not rely on fossil fuels (gas) and the schemes include highly efficient hot water cylinders, solar PV, high heat retention storage heaters on an economy 7 tariff, and infrared heating panels. The Clos Holm View site includes 10 properties with **rainwater harvesting for toilet flushing**. External EV chargers have been added at Olive Lodge, and provide a stop of point for our fleet team to recharge when en-route through Barry, which is more energy efficient than returning to the Civic or Alps buildings to recharge during the working day.

For our existing housing stock, **retrofit activities continue** supported by the Welsh Government's Optimised Retrofit Programme (ORP) grant. Work is ongoing on 26 properties including the addition of solar PV and batteries, heat recovery on waste water, and wrapping the buildings in additional external wall insulation. This work will continue through the summer of 2026. A second project to install solar PV in 44 social homes has progressed well with most homes taking up the offer. However, there have been a small number of homes who have refused this installation and alternative properties have been substituted in their place.

In addition, we have installed **data sensors** across a number of our void properties with known issues. These will monitor internal temperature, humidity, Carbon Dioxide and Carbon Monoxide. This project has gone well and we are keen to extend it over the next few years to all our homes to support early recognition of potential problems.

Highlights



Work at Ysgol Llyn Derw, a second site for Ysgol y Deri, continues with a new contractor after the original contractor went into administration. The building is **meeting both Net Zero Carbon in Operation (NZCiO) projections, and Welsh Government Carbon requirements**. Building of the St Richard Gwyn High School project began in Barry, the project is meeting the Embodied Carbon requirements, and additional opportunities are being scoped to meet NZCiO requirements as the green roof which is needed for SuDs has limited the number of solar panels that can be included. The work at Ysgol Iolo Morganwg primary school in Cowbridge has now completed the RIBA Stage 4 design: currently the development is meeting both Embodied Carbon and NZCiO. All of these new build projects exceed the threshold for the BREEAM Excellent standard, and collectively they include an array of carbon reduction measures such as solar panels, air source heat pumps, green roofs, EV charging, and a thermally efficient facade.

There has been **slower than expected progress against PZC15.5**: use of the Old Hockey Pitch at Ysgol Gymraeg Sant Gurig has been proposed for use by the school and the Vale Local Nature Partnership as a nature reserve and is being considered. There has been no progress against PZC15.3 due to a lack of funding for the annual monitoring of performance of new schools post-completion. For future projects we are ensuring that visibility of energy saving technology is provided for all new developments at handover.

Other highlights in the period include the **launch of a new school's eco-directory**, a resource for Head Teachers, Eco-schools Leads and all other school staff working towards eco and decarbonisation goals. The directory is designed to help schools become more sustainable while reducing operational costs.

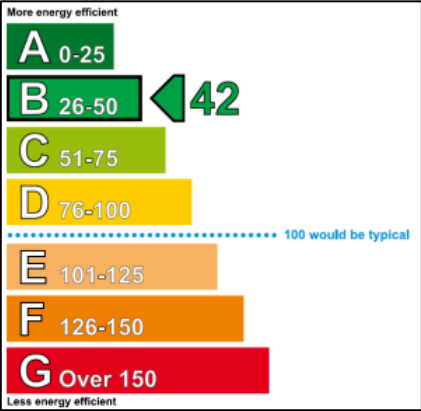
In Decarbonisation & Energy, more capacity has been added to the team with the successful recruitment of a Decarbonisation & Energy Officer and Principal Officer role, enabling **more focused work on behaviour change in schools, development of a new energy manager live handbook and a review of decarbonisation opportunities**. A new platform, iQVision, is now set up allowing for centralised controls of heating and building services systems across a significant proportion of the estate and is helping us to support sites monitor their energy use and reduce out of hours usage. Training sessions were held with the relevant schools during March to help them view their own pages and see how the platform could help them operate their sites more energy efficiently.



A new 18kW PV array was installed at the **Cosmeston Warden's office** as part of the roof renewal and WC refurbishment project. Feasibility works commenced at St Cyres and Ysgol y Deri (PLC) and continued project management of our retrofit air source heat pump and solar PV projects to be delivered 2025/26 and into 2026/7. PV (photovoltaic) arrays (15kW) have been installed at **Rhws Primary (nursery block)** this will reduce the Primary School site's electricity bill. When comparing 2025/26 with 2024/25 we can see the site experienced a 20% reduction in grid electricity use, a saving of more than £6,000 for on-site generation and behaviour changes.

Display Energy Certificates have been renewed across a large proportion of the estate during November / December 2025 the trend continues to improve across the estate with a larger proportion of buildings securing a C rating. Further updates will continue to be completed in 2026/27.

Grant funding worth £20k from Welsh Government Energy Services has **enabled energy efficiency feasibility designs to be developed for Barry Library & Town Hall, and Civic Offices**. Some of the recommendations for each site will progress during 2026/27 with capital funding. An additional £35k grant from Ystadau Cymru enabled our five leisure centres to have energy audits completed. Both projects will provide clearer guidance on future decarbonisation opportunities linked to the capital programme and other funding sources.



At Barry Island, new LED lanterns have been installed around the funfair area, improving light quality, reliability and energy efficiency. The scheme also incorporates smart Central Management System (CMS) technology, allowing lighting to be monitored and programmed remotely. Further upgrades along the Barry Island seafront footways will be undertaken in the near future using the same bespoke-style lanterns, creating a consistent and high-quality appearance across the area.

In addition, an innovative scheme is being trialled along Cogan Pill Road footpath. This route currently has no street lighting, and due to ecological considerations, the Council has installed **bat-friendly lighting** using low correlated colour temperature lanterns designed to minimise impact on wildlife. The scheme will also trial a **multi-use sensor system** which detects pedestrian movement. When activated, several lanterns will illuminate together and will automatically dim or switch off once no activity is detected. This approach improves safety for users while delivering further energy savings and reducing environmental impact.

Project Zero: Challenge 17

Highlights



In 2025/26 the **numbers of EV vehicles in our fleet has grown**, with 43 of our fleet fully electric and 9 hybrid from a total of 324. In Q3 & 4, eight new EV vans funded by a Welsh Government Energy Services (WGES) grant became operational. Six are being used by our Highways Inspectors and two by our Waste Team Supervisors. On average, 7,000 miles is travelled by each of these vehicles per year, meaning that the switch from diesel to EV will greatly reduce emissions, supporting our net zero goals, and improving air quality too.

In relation to **charging infrastructure**, WGES are undertaking a review of EV charging requirements at Atlantic Trading estate vehicle parking with a view to transitioning more of the waste fleet to EV. Two new EV charge points have been installed at Olive Lodge, a social housing scheme in Barry. This provides a useful recharging point for our fleet as staff move around the Vale.

In relation to supporting active travel and greener staff commuting, **39 bikes were purchased in 2025 through the cycle to work scheme, saving an estimated £344 each**. As well as reducing emissions, cycling helps the workforce stay active and reduce costs such as parking and fuel. In June / July we will be running the annual staff travel survey to understand staff travel patterns and support the data needed for the 2025/26 Net Zero Carbon submission to Welsh Government. During Bike Week in June we will be running cycle roadshows for staff and in the community. As more staff move to the Civic, car park barriers will be introduced and EV parking bays protected.

Project Zero: Challenge 18

Invest in technology to support homeworking and online services reducing the need for travel and office space.

Highlights

Through Q3/Q4, we **completed a migration to Amazon Web Services (AWS)** and moved the vast majority of our servers to cloud computing. AWS invest significantly in highly optimised computing power where the carbon usage is lower than in our own environment. Our in-house Data Centres will be decommissioned in Q1/Q2 of 26/27 and represent a saving and cost mitigation for the organisation.



Our Digital team has been working closely with colleagues across services to modernise how residents interact with the Council, for example, the introduction of the **new e-billing service for council tax**. Residents in the Vale are now able to view their bills and account information online - making information easier to access at any time, reducing printing and postage costs, and helping to free up resources that can instead support frontline services. Using less paper also reduces carbon emissions, supporting the Council's Project Zero ambition to become carbon neutral by 2030.

As the new print strategy beds in, our **total print volume has decreased by over 25% year on year** with reductions in Q4 particularly high. Hybrid Mail utilisation has increased by 24% and is a more cost and carbon effective way of sending printed mail. Our net print reduction is 21%

Our planned activities to September 2026 include **decommissioning our server rooms, and continued communications on print reduction**.
