# APPOINTMENTS PANEL RE STANDARDS COMMITTEE

# (a) Declarations of Interest -

No declarations were received.

## (b) Appointment of Chairman of the Panel for the Municipal Year -

AGREED – T H A T Councillor L.O. Rowlands be appointed Chairman of the Panel for the Municipal Year.

### (c) <u>Appointment of Independent Member to Serve on the Council's Standards</u> <u>Committee: Criteria and Advert (MO/HLDS)</u> –

The Monitoring Officer / Head of Legal and Democratic Services, in presenting the report, advised on the appointment process that had been undertaken for the appointment of Independent Members of the Standards Committee from 13<sup>th</sup> March, 2019 following the terms of office of two current Members coming to an end at that time. The process of appointing Independent Members had been approved by Full Council with the remit of the Appointments Panel being to consider applications and report any recommendations to the Standards Committee Appointments Committee.

The Appointments Panel had met on 26<sup>th</sup> November, 2018 and considered applications for short listing for interview. Attached as an appendix to the report was a copy of the criteria and adverts for the appointment of Independent Members for Members' information.

At the meeting on 26<sup>th</sup> November, 2018, five candidates were short listed for interview.
