This means our Community Council is not quorate.</p>
<p>Details of the Prejudicial Interest</p>	<p>The Vale of Glamorgan Council are currently consulting on a proposed new road between M4 junction 34 and the A48 at Sycamore Cross. One option being pursued runs across the field next to out house whilst the other option <del>is</del> runs across the field on the other side of our house. The proposed road will cause undue levels of light, noise and air pollution. This will therefore give me a prejudiciary interest.</p>
<p>Details of any Position of responsibility / control held on your Council (e.g. Chairman / Vice-Chairman / Cabinet Member)</p>	<p>I am a member of the Pendoylan Community Council and, with others, am responsible for planning issues.</p>
<p>Reason(s) to support the application and why you consider the Standards Committee should grant a dispensation  (Use a separate sheet of paper if necessary)</p>	<p>The Pendoylan Community Council currently consists of 6 Councillors, the majority of whom have an interest in the proposed road. A large number of residents expect the Community Council to act on there behalf. I believe that the WELTAG process including consultation needs to be conducted in a fair manner to ensure that those directly affected by the plans are able to engage and respond. The Community Council should be in a position to report the facts of the process and receive individual comments from those we represent. A dispensation to engage in conversations regarding the process, including any decisions on what the Community Council should be raising as potential unfairness to the Community, would allow me with fellow Councillors ensure we keep an impartial view with regard to options whilst ensuring the process remains fair to all in the Community.</p>
