Recommendations

Reasons for Recommendations

1. To comply with the regulations and obligations for the grant of dispensations to speak and vote.
2. Having regard to the use of delegated powers under the Council's Constitution.

1. Background

- 1.1 The Standards Committee Grant of Dispensations (Wales) Regulations 2001 permits Members to apply to Standards Committee to speak and, if appropriate, to vote on issues which due to prejudicial interests, they may not otherwise be able to speak or vote or remain in the room.
- 1.2 In order to deal with the applications as quickly as possible, it is necessary for the Standards Committee to receive full information of the interests involved and why in the Member's opinion dispensation should be given.
- 1.3 Applicants are advised that they are also able to attend the Standards Committee meeting to present their application if they wish to do so.

2. Key Issues for Consideration

- 2.1 Firstly, Committee is requested to consider and determine an application for dispensation from Councillor N. Moore to speak and vote on issues relating to Bowling Clubs within the Local Authority attached at Appendix 1 to this report.
- 2.2 Secondly, an application for dispensation was considered and granted by the Monitoring Officer under delegated powers in consultation with the Chairman of the Standards Committee on 2nd October 2020. The dispensation granted was in respect of Vale of Glamorgan Council Councillor K.F. McCaffer's application to speak and vote on matters in relation to Stanwell School at all meetings of the Vale of Glamorgan Council when the issues arise. The Monitoring Officer, in consultation with the Chairman of the Standards Committee, and in light of the Committee's Resolution on 24th January, 2019 (Min. No. 687) granted a dispensation under paragraphs (d), (e), (f) and (i) of the Standards Committee (Grant of Dispensations) (Wales) Regulations 2001, to speak and vote until the date of the next Local Government elections. The Committee is requested to note the use of delegated powers in respect of the application attached at Appendix 2 to this report.

- 3.1** One of the roles and functions of the Standards Committee (as detailed in the Council's Constitution) is to consider the granting of dispensations to Councillors, Co-opted Members and Church and Parent Governor Representatives from requirements relating to interests set out in the Members' Code of Conduct.

The Standards Committees (Grant of Dispensations) (Wales) Regulations 2001 specifies that the Council's Standards Committee may grant dispensations under Section 81(4) of the Local Government Act 2000 where:

- (a) no fewer than half of the Members of the Council or of a committee of the Council (as the case may be) by which the business is to be considered has an interest which relates to that business;
- (b) no fewer than half of the Members of the Executive of the Council (i.e. Leader and Cabinet) by which the business is to be considered has an interest which relates to that business and either paragraph (d) or (e) also applies;
- (c) Members' inability to participate would upset the political balance of the Council, or any of its committees by which the business is to be considered, to such an extent that the outcome would be likely to be affected;
- (d) the nature of the Member's interest is such that the Member's participation in the business to which the interest relates would not damage public confidence in the conduct of the Council's business;
- (e) the interest is common to the Member and a significant proportion of the general public;
