Report Title:	Appointment of a Standards Committee Panel
Purpose of Report:	To consider the appointment of a Standards Committee Panel to consider undertaking a review.

Executive Summary:

- The Standards Committee are asked to consider whether to undertake a review having regard to comments made at the Full Council meeting on 5th December, 2022.
- Should the Standards Committee consider a review would be appropriate, the Standards Committee to consider establishing a Panel to undertake the Review with Panel membership consisting of three Independent Members.
- Should the Standards Committee consider establishing a Panel to be established, the Panel be convened to consider the Terms of Reference for such a review and for the Terms of reference to be reported for consideration at the next meeting of the Standards Committee.

Recommendations

- 1. That the Standards Committee considers the contents of this report and whether to set up a Panel of Independent Members of the Standards Committee to consider conducting a review in respect of the matter referred to in paragraph 1.1 of this report.
- 2. That should the Committee agree to establishing a Panel as outlined in Recommendation (1) above, that the Panel consists of three Independent Members of the Standards Committee.
- **3.** That following approval of the establishment of a Panel, the Panel be convened to consider the Terms of Reference for such a review and for the Terms of reference to be reported for consideration to the next meeting of the Standards Committee.

1. Background

- 1.1 At the Full Council meeting on 5th December, 2022 a Member asked whether the Leader was prepared to undertake an Inquiry in relation to a former Vale of Glamorgan Councillor who had recently been found guilty of offences before the Newport Crown Court on 25th November 2022. (Min no 512 (xxxiii) refers.). The link to the Council minutes of 5th December 2022 being reproduced below.
- **1.2** A meeting regarding this matter was convened in December 2022 attended by the Member making the above request, his Group Leader, the Chair of Standards Committee and the Monitoring Officer / Head of Legal and Democratic Services.

- **2.1** Having regard to paragraph 1.1 above, Committee is advised that there is no legal basis for the Council to undertake an Inquiry of its own volition as it is a matter for Ministerial Authorisation.
- 2.2 The Standards Committee may if deemed appropriate consider appointing a Panel to undertake a review of the matters as outlined in paragraph 1.1 above and min no 512 (xxxiii). - 2.4 Should the Standards Committee agree to the appointment of a Panel to undertake a review, the Panel be convened to determine the Terms of Reference of the Panel and the terms of reference be reported to the next meeting of the Standards Committee for consideration and / or approval.
