<p>Executive Summary:</p> <ul style="list-style-type: none"> <li>The Vale of Glamorgan Council is working in collaboration with Wales &amp; West Housing Association (WWHA) to deliver a project called <i>Penarth Older Persons Housing with Care Complex</i> (Penarth OPHwCC) on land located off Myrtle Close in Penarth.</li> <li>An additional cycleway/footway (or footway only) link to the Cosmeston lake area has been proposed for the benefit of community however there is no space within the boundary of the site to accommodate the footpath on the development land. The Council/developer approached the Trust in relation to utilising the Trust's land for the footpath.</li> <li>Further detail is set out in the Part II report on this agenda.</li> </ul>

- 1.1 The Vale of Glamorgan Council is working in collaboration with Wales & West Housing Association (WWHA) to deliver a project called *Penarth Older Persons Housing with Care Complex* (Penarth OPHwCC) on land located off Myrtle Close in Penarth.
- 1.2 Both the Vale of Glamorgan Council and contractors Hale hoped to construct a link to the Cosmeston lake area within the Extra Care site boundary for the benefit of the community, but this has now been confirmed as not being possible due to site and cost constraints.
